## Children and Young People's Plan

Somerset County Council and its partners will soon be publishing the next Children and Young People's Plan for 2019 to 2022.

It is the vision of all services working with vulnerable children and families - including children and young people with Special Educational Needs and /or Disabilities, aimed at improving not just individuals' lives but the communities supporting them.

At the centre of the process were young people who attended three workshops with senior leaders to discuss priorities for the plan,.

And last month eight of the young people from those workshops came to Somerset County Council to help write the new plan.

## New special school for South Somerset a step closer

A bid by Somerset County Council to establish a new special free school in South Somerset has moved a step closer.

This week the DfE informed the Council that its free school bid had been selected by the Secretary of State to proceed to the trust competition stage.

It means that if successful, the Council will secure the significant capital investment required to build a new Special School catering for up



to 120 children with Social Emotional & Mental Health needs or Speech Language & Communication Needs.

At the moment, Somerset's only similar maintained special school is Sky College in Taunton, meaning children in South Somerset have to

travel long distances to access that type of provision.

It's an exciting development and is a boost to Somerset and its Local First approach to ensure more children and young people with special educational needs can be educated in good quality provision close to home.

Next week we'll bring a more detailed update on the projects that are delivering additional special school places in Taunton and Bridgwater.
