

**SOMERSET COUNTY COUNCIL**  
**(A39 MAIN ROAD, KILVE AND A39 WILLITON TO**

**(TEMPORARY TRAFFIC RESTRICTIONS)**  
**ORDER 2015**

NOTICE is hereby given that Somerset County Council in exercise of its provisions of section 14(1) of the Traffic Regulation Act 1984, as amended, will introduce a temporary Prohibition of Driving on the lengths of road listed in the Schedules below to this Notice.

- i. The Notice is required because carriageway resurfacing works are being executed on or near the roads listed in the schedules below. The restrictions may not be effected for the whole period but it is anticipated that the roads will be restricted as and when traffic signs are in position and only for so long as is necessary to execute the works for a period not exceeding 18 months. The works are anticipated to be operative between the hours of 1830 until 2330 as follows:
  - i. Main Road, KILVE:- Monday 1<sup>st</sup> June to Friday 5<sup>th</sup> June 2015.
  - ii. Williton to Bridgwater Road, HOLFORD:- Monday 8<sup>th</sup> June to Friday 12<sup>th</sup> June 2015.

**SCHEDULE 1**  
**TEMPORARY PROHIBITION OF DRIVING**  
**A39 MAIN ROAD, KILVE**  
**From Monday 1st June to Friday 5th June 2015**  
**between the hours of 1830 and 2330**

From 100 metres east of its junction with Putsham Mead to 510 metres west of its junction with Pardletone Lane. A total distance of approximately 600 metres.

**SCHEDULE 2**  
**TEMPORARY PROHIBITION OF DRIVING**  
**A39 WILLITON TO BRIDGWATER ROAD, HOLFORD**  
**From Monday 8th June to Friday 12th June 2015.**  
**between the hours of 1830 and 2330**

From 110 metres south of its junction with Church Road to 150 metres north of its junction with Portway Lane. A total distance of approximately 370 metres.

**ALTERNATIVE ROUTE**

From the eastern end of the closure for Kilve and from the southern end of the closure for Holford, proceed in a south easterly direction along the A39 to the junction with the A38. Turn right and proceed in south easterly and south westerly directions along the A38 to the junction with the A3259. Turn right and proceed in south westerly and north westerly directions along the A3259 and the A358 to the junction with the A39. Turn right and proceed in south easterly and north easterly directions along the A39 to the western and northern end of the closure, and vice versa.

Vehicles over 4.2 Mt (13' 9") High will be diverted via the B3227 the B3224 and the B3190 to the A39.

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

- 1 This Order shall come into operation on 1<sup>st</sup> day of June 2015 and shall remain in force for eighteen months. The works are expected to last for two weeks.
  
- 2 This Order is made to facilitate carriageway resurfacing works are being executed on or near the roads listed in the schedules below. The restrictions may not be effected for the whole period but it is anticipated that the roads will be restricted as and when traffic signs are in position and only for so long as is necessary to execute the works for a period not exceeding 18 months. The works are anticipated to be operative between the hours of 1830 until 2330 as follows:
  - iii. Main Road, KILVE:- Monday 1<sup>st</sup> June to Friday 5<sup>th</sup> June 2015.
  - iv. Williton to Bridgwater Road, HOLFORD:- Monday 8<sup>th</sup> June to Friday 12<sup>th</sup> June 2015.
  
- 3 Save as provided in Article 4, the following temporary traffic restrictions are introduced:

PROHIBITION OF DRIVING on the A39 Main Road, Kilve and on the A39 Williton to Bridgwater Road, Holford as detailed in Schedule 1 and 2;
  
- 4 Nothing in Article 3 of this Order shall apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
  
- 5 This Order shall be cited as THE COUNTY OF SOMERSET (A39 MAIN ROAD, KILVE AND A39 WILLITON TO BRIDGWATER ROAD, HOLFORD) (TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2015

Turn right and proceed in south easterly and south westerly directions along the A38 to the junction with the A3259. Turn right and proceed in south westerly and north westerly directions along the A3259 and the A358 to the junction with the A39. Turn right and proceed in south easterly and north easterly directions along the A39 to the western and northern end of the closure, and vice versa.

Vehicles over 4.2 Mt (13' 9") High will be diverted via the B3227 the B3224 and the B3190 to the A39.
