TAKE NOTICE that in pursuance of Section 14(1) of the Road Traffic Regulations Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the County Council of Somerset propose to make an Order to introduce a temporary 30 MPH Speed Limit along New Road, Lufton, Yeovil for a distance of 150 metres.

- 1 This Order is made to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties.
- 2 The Order becomes effective on Thursday 30th July 2015 and will remain in force for eighteen months.
- 3 The temporary traffic restrictions will come into operation when signed and will remain in force only for as long as is necessary.
