Introduction

This Plan deals with flood emergencies that are of a scale that cannot be dealt with by the Emergency Services, Local Authorities and other agencies as part of their normal day-to-day operations. The Plan provides the framework for responding to all forms of major flooding events across the County. Because of the potential scale of flooding, and the consequential effect on large numbers of homes and people, the Plan detail concentrates on six specific sites that have been identified by the Environment Agency as needing specific plans.

Flooding is a widespread occurrence in Somerset, the public have their part to play in acknowledging the risk to their property and taking preventative measures to minimise the effects of flooding on their premises.

In large scale, perhaps countywide flooding emergencies, residents and small communities will not be able to rely on the Emergency Services and others for responding to their immediate needs. In these circumstances residents are encouraged to develop a local community self help plan for themselves.

Aim

The Plan provides an overview of tactical and operational of actions, roles and responsibilities specific to flooding in the County of Somerset, and details the multi-agency operational response. This Plan includes information referenced from the Avon & Somerset Local Resilience Forum (LRF) Multi Agency Flood Plan to produce a framework of procedures to facilitate a co-ordinated multi-agency response to flooding within the County boundary.

Objectives

- To provide clear definitions of roles, responsibilities and actions of each agency at particular stages of a response.
- Set out multi-agency command and control arrangements at each level of response.
- Identify lead officers as part of the response and recovery process.

Major Flood Risk Sites

While flooding is a regular occurrence within Somerset, the Environment Agency flood risk assessment highlights 6 sites where there is a need to have a specific flood response plan. These sites are identified either because of their potential for large numbers of people to be at risk in a single location, or where there is such a short time between warning and actual flooding that affected communities and responding agencies need to react immediately.

Roles and Responsibilities

The roles and responsibilities of agencies and authorities are defined in the A&S LRF MIRG.

In basis terms they are:

- Police: Coordination of Response Phase, protection and saving of life.
- Fire Service: Search and Rescue, may assist with notification of at risk communities.
- Ambulance: Triage of casualties, transport of medically vulnerable people.

- Health: Provide clinical response and general support and specialist healthcare during response and recovery phases.
- Local Authorities: Support to Emergency Services, Traffic Management, Transport during evacuation and establishment of Rest Centres. Lead Recovery Phase.
- Environment Agency: Flood warning, defensive work where appropriate, notification of at risk communities.
- Highways Agency: Management of major route network, route closures, clearing debris from route network, signage, repairs
- Utilities: Identification of at risk critical infrastructure.
- Animal Health: Advice to farmers regarding livestock and links to Animal Charities
- Voluntary Agencies: Support to Local Authorities

Other Organisations that may be involved:

- Transport industry, including train operators and Network Rail.
- British Transport Police
- Civil Nuclear Constabulary
- Pipeline operators
- UK Search and Rescue
- Maritime and Coastguard Agency
- Community Groups, Flood Warden schemes

Sources of Flooding

River (Fluvial) Flooding

- A river bursting its banks leading to flooding is usually caused by prolonged periods of heavy rainfall (or melting snow). Fluvial flooding can be both deep and high velocity, depending on the nature of the river catchment. The area affected by fluvial flooding has been mapped by the Environment Agency.
- Within Somerset, due to the topography of the flood plain areas there is little difference between the extent of flood zones 2 and 3. The total number of properties at risk from river flooding is 5, 412.
- The Environment Agency will monitor and warn for river (fluvial) flooding where systems and procedures are in place,

Tidal & Coastal Flooding

- The combination of high astronomical tides and adverse weather conditions can cause storm surge and wave overtopping of defences.
 In severe events this may result in the breach of sea defences and inundation of the surrounding area.
- Risk to life can be high with the potential for people being caught in fast flowing waters and currents adding to the usual risks associated with flooding. In vulnerable areas there is potential for significant damage to property from high-energy waves.
- At risk communities along the Somerset coast are largely defended to at least a 1 in 200 year standard. There are 16,415 properties at risk from a 1:1000 year event (Flood Zone 2).

Surface Water Flooding

- Surface water flooding happens where drainage systems are unable to cope with heavy spells of rainfall, are blocked or damaged. In rural areas It will be most problematic when catchments are already saturated or the ground hard due to lack of rain or frozen and in urban areas with impermeable surfaces. It will usually occur rapidly, but be relatively short lived.
- Accurately predicting and mapping surface water flooding is currently is being progressed by DEFRA and the EA. DEFRA has identified 104 settlements (17,060 properties) within Somerset that are at risk of surface water flooding. The Extreme Rainfall Alert Service provides the best available information for warning of potential surface water flooding to Category 1 and 2 Responders, but is unable to provide a specific location but will endeavour to provide a geographic area. Affected communities will largely rely on their local understanding of the most commonly affected areas.

Reservoirs Breach

• This refers to a collapse of a reservoir dam, there are a number of reservoirs within the Somerset area and these could cause flooding if a collapse occurred. Flooding from these would be instantaneous with significant movement of debris (including vehicles) and sediment. It is likely that there will be little or no warning, and the impact is likely to be devastating to anything in the floods wake. In Somerset there are currently 11 identified Category A Reservoirs¹ (over 25,000m³), which may require emergency plans. Reservoir Emergency Plans are separate to this Plan and not considered further. A list of major Reservoirs is at Annex I

Groundwater Flooding

 Groundwater flooding is the result of a rise in the water table to above the rock or soil that makes up the land surface. The problem is most common in areas with chalk strata but can occur in any area with underlying permeable deposits, including sands and gravels. Somerset is not at significant risk from this type of flooding and is not considered further in this Plan.

Critical Infrastructure

Maps are included at Annex J of the sites that are regarded as Critical Infrastructure within Somerset. They include Health Sites and should be identified early in the FASTCON to ensure that appropriate measures are taken for either their protection or evacuation.

Generic Response

The Response Phase will be led and co-ordinated by the Police.



Operational trigger points for action

Somerset Levels and Moors flood risk management

Background

As part of our contribution towards the Somerset Flood Action Plan, we are developing a set of 'Operational Trigger Points' for the Somerset Levels. This piece of work will help clarify how we manage flood risk in an extraordinary flood event - just like we experienced in winter 2013-14. These Trigger Points will explain when we are able, and decide, to take action at particular sites during an event - and describe what people would see happening on the ground. A summary of what people will expect to see happening at the named sites is outlined in this briefing.

Where are the trigger points?

Eight of our trigger points are at Environment Agency pumping stations. They include bringing in more pumps when certain things happen such as roads flooding. The condition throughout, is that as well as the local trigger being met, for that area there will also be rain forecast for the next 3-5 days (cumulative total of 100 mm or greater) and moor levels rising at 5cm/hour or more.

Pumps in the pumping stations are set to operate automatically according to water levels in the rhynes draining the moor. They cannot pump if there is no space to receive water into the receiving river. When spillways are operating or river banks are overflowing, the pumps cannot operate.

The other two trigger points relate to the use of the River Sowy and Kings Sedgemoor Drain to divert water from the River Parrett.

Currymoor, Saltmoor and Northmoor Pumping Stations

Currymoor, Saltmoor and Northmoor triggers are interlinked. The level on Currymoor rises due to spillways running from the River Tone into Currymoor. This means the pumps can't operate. Cutts Road floods first, and then New Road. The trigger is when New Road floods. At this point additional temporary pumps will be put in earlier and all in one go at;

- 1 Currymoor Pumping Station for the time when pumping can resume;
- 2 Saltmoor and Northmoor Pumping Stations. All pumps can operate on all but the very highest spring tides.

West Sedgemoor Pumping Station

The permanent pumps will operate until the River Parrett reaches a level where Beasley's spillway runs.

Additional temporary pumps will be put in at West Sedgemoor Pumping Station when the lowest roads flood ready for when pumping can resume. When Beasley's Spillway stops running all permanent and temporary pumps will be turned on in sequence

Westover Pumping Station

When flooding is predicted all inlets to the moor will be manually closed and water will continue through the river systems. The permanent pumps will continue to operate automatically until the Parrett overtops its banks upstream.

The Drayton to Muchelney road floods first, then the lowest part of the Westover Trading estate road.

Additional temporary pumps will be put at the pumping station when the Westover Trading estate road floods

Huish Episcopi Pumping Station

When flooding is predicted all inlets to the moor will be manually closed and water will continue through the river systems. The permanent pumps will continue to operate automatically until the River Yeo overtops its banks. The land starts to flood and then flooding reaches the Langport to Muchelney Road, then Muchelney to Long Load road. When the Muchelney to Long Load Road floods, additional temporary pumps will be put at the pumping station to operate once the Yeo is below bank height.

Long Load Pumping Station

When flooding is predicted all inlets to the moor will be manually closed and water will continue through the river systems. The permanent pumps will continue to operate until the River Yeo overtops its banks. The Long Sutton road floods at which time additional temporary pumps will be put at the pumping station. As soon as the river is below bank height pumps will be turned on in sequence to avoid overtopping

Westonzoyland Pumping Station

When flooding is predicted all inlets to the moor will be manually closed and water will continue through the river systems. When flooding occurs and lowest fields flood the permanent pump will operate. When the lowest road in Middlezoy floods an additional 1 cumec pump will be put in at the pumping station. All pumps operate on all but highest tide peaks. NB no additional pumps can be added at Lakewall.

Sowy and Kings Sedgemoor Drain

When flooding is predicted, Oath Lock is opened. Monksleaze Clyce is opened partially to lower river levels in the Parrett and allow pumping to continue upstream of Langport.

At the onset of flooding, Monksleaze Clyce is closed because Allermoor and Beasley's Spillways will run. (Having the Clyce open AND spillways running may increase the flood risk to Sowy system)

When Parrett levels are declining and spillways are predicted to stop running, Monksleaze Clyce will be fully opened incrementally depending on keeping the Sowy below bank height downstream of Beer Wall as desired by the IDB. Temporary pumps will be put at Dunball before Monksleaze Clyce is fully opened
