(AMENDMENT NO. 4 – GREAT WESTERN STREET)
ORDER 2016

Somerset County Council in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”), as amended; and the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”), as amended, and all other enabling powers; and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:

The County of Somerset Prohibition and Restriction of Stopping, Waiting, Loading and Unloading and On-street Parking West Somerset Order 2012 shall be amended by the revocation of the Map Schedule specified in the First Schedule to this Order and the insertion of the Map Schedule specified in the Second Schedule to this Order.

The provisions of the following Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order

(MENDIP ORDER 2012 AMENDMENT ONE AND TWO)

The effect of the Order shall be:

NO WAITING AT ANY TIME

Great Western Street, Frome
(western side)

From its junction with Wallbridge for a distance of 86 metres in a northerly, then north-easterly direction

Great Western Street, Frome
(eastern side)

From its junction with Wallbridge for a distance of 81 metres in a northerly, then north-easterly direction

This Order shall come into operation on the 29th of January 2016 and may be cited as “The County of Somerset Prohibition and Restriction of Stopping, Waiting Loading

and Unloading On-street Parking Mendip Order 2012 (Amendment No.4 – Great Western Street) Order 2015”.
