THE COUNTY OF SOMERSET PROHIBITION AND RESTRICTION OF STOPPING, WAITING, LOADING AND UNLOADING AND ON-STREET PARKING TAUNTON DEANE 2012 (RESIDENTS PARKING AMENDMENT ORDER 2016)

Somerset County Council in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), as amended; and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004"), as amended, and all other enabling powers; and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

The County of Somerset Prohibition and Restriction of Stopping, Waiting, Loading and Unloading and On-street Parking Taunton Deane Order 2012 shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedule specified in the Second Schedule to this Order.

The provisions of the following Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this order.

(North side)	a distance of 5 metres in a north

RESIDENT PERMIT HOLDERS ONLY MON-SAT 8AM – 6PM

Middle Street, Taunton (south east side)	From a point 23 metres south west of the junction with Canon Street for a distance of 100 metres in a south westerly direction
