SOMERSET COUNTY COUNCIL (A356 FROM THE A303 TO BROADSHARD) (CREWKERNE) (WEST STREET, STOKE SUB HAMDON) (REVOCATION OF 50 MPH SPEED LIMIT) (30 MPH SPEED LIMIT) AND (50 MPH SPEED LIMIT) ORDER 2016

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 (1) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- This Order shall come into force on the 2nd June 2016 and may be cited as the "Somerset County Council (A356 from the A303 to Broadshard) (Crewkerne) (West Street, Stoke sub Hamdon) (Revocation of 50 MPH Speed Limit) (30 MPH Speed Limit) and (50 MPH Speed Limit) Order 2016".
- 2. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this order.
- 3. No person shall drive any motor vehicle at a speed exceeding 30 MPH on the lengths of road as specified in Schedule 1 to this order.
- 4. No person shall drive any motor vehicle at a speed exceeding 50 MPH on the lengths of road as specified in Schedule 2 to this order.

SCHEDULE 1 30 mph Speed Limit (Extension of the existing 30 mph Speed Limit)

A356 Broadshard Road

From a point 109 metres north east of the centre of its junction with Merriott Road for a distance of 350 metres in a north easterly direction.

SCHEDULE 2 50 mph Speed Limit

A356 from Merriotsford near Crewkerne to the A303

From a point 366 metres north east of its junction with Haselbury Road for a distance of 5680 metres in a northerly direction.

West Street, Stoke sub Hamdon From its junction with the A356 for a distance of 635 metres in an easterly direction.

SCHEDULE 3 Revocation

Any existing speed limit order relating to the length of road specified in Schedule 1 to this Order is hereby revoked.
