

**SOMERSET COUNTY COUNCIL**  
**(A367 BATH ROAD)**  
**(PARISHES OF OAKHILL AND STRATTON ON THE FOSSE)**  
**(REVOCATION AND 40MPH SPEED LIMIT) ORDER 2016**

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 (1) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 22nd day of December 2016 and may be cited as the "Somerset County Council (A367 Bath Road) (Parishes of Oakhill and Stratton On The Fosse) (Revocation and 40mph Speed Limit) Order 2016".
2. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedules to this Order.

**SCHEDULE 1**  
**40 mph Speed Limit**

A367 Bath Road at Oakhill	the A367 Shepton Mallet to Radstock Road north of Oakhill, from a point 281 metres north of its junction with Fosse Road northwards for a distance of approximately 2081 metres to its junction with the B3356 Green Lane to Bath Road and Pitcot Lane.
Bath Road, Access to Ivy Cottages, Stratton on the Fosse	136 metres from with A367 Bath Road junction near 'The Pastoral' heading south west for a distance of approximately 170 metres to Ivy Cottages.
Bath Road, access to Sewerage Works, Stratton on the Fosse	To its junction with the A367 Bath Road in a southerly direction for a distance of 451 metres.

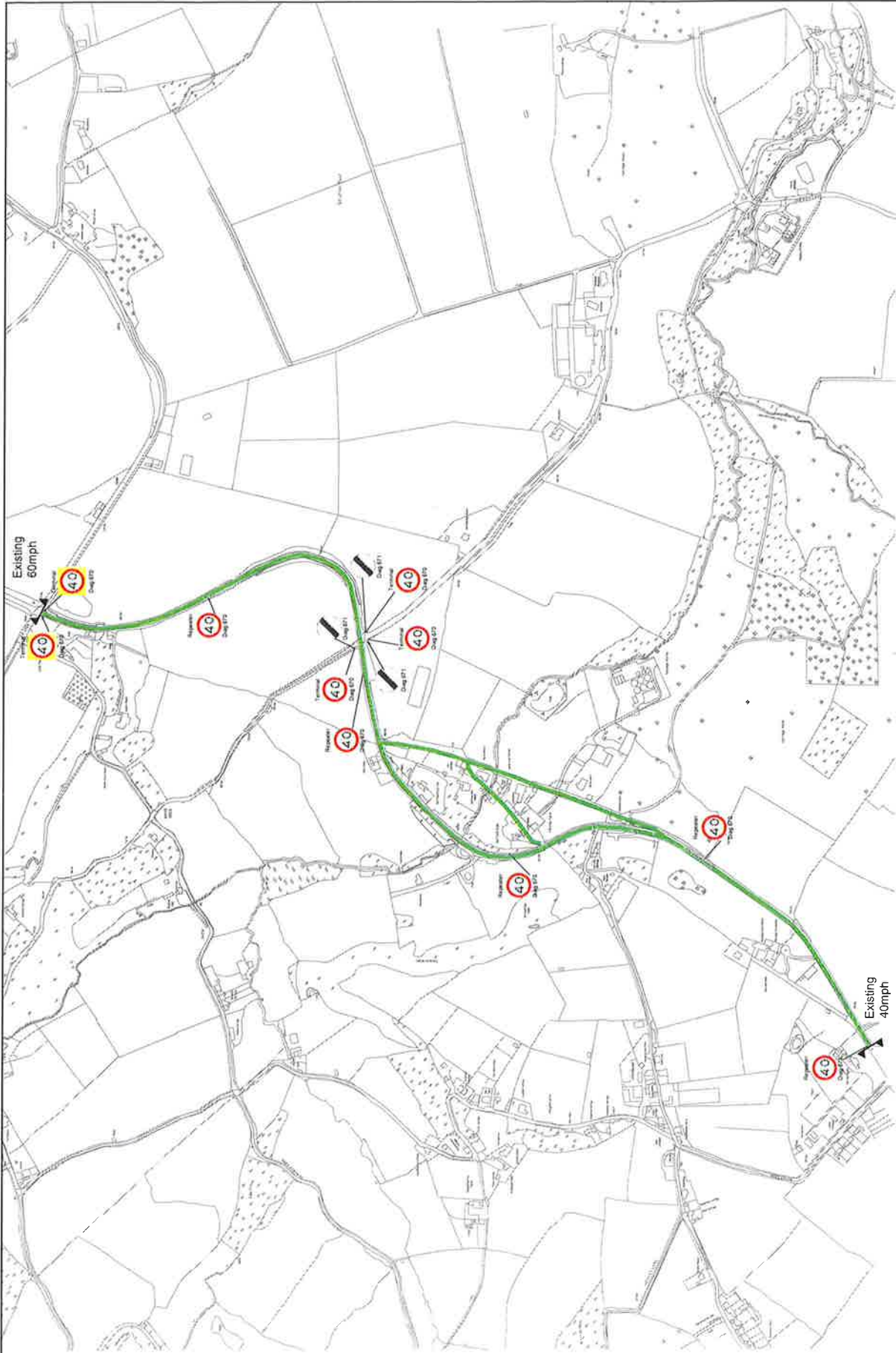
