

SOMERSET COUNTY COUNCIL
(A38 SHUTTERN, UPPER HIGH STREET, MARY STREET
BILLETFIELD AND HURDLE WAY, TAUNTON)
(TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2017

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

- 1 This Order shall come into operation on the 19th day of January 2017 and shall remain in force for eighteen months. The works will commence on the 30th January 2017 for 10 evenings excluding the weekend from 18:30hrs to 23:30hrs. The restrictions may not be effected for the whole period but it is anticipated that the road will be restricted as and when traffic signs are in position and only for so long as is necessary.
- 2 No person except upon the direction of a police constable in uniform shall cause or permit any vehicle to proceed in the length of road in Schedule 1 in an Easterly direction.
- 3 No person except upon the direction of a police constable in uniform shall cause or permit any vehicle proceeding in the road specified in column 1 of Schedule 2 to this Notice from making a right turn into the road specified in column 2 of the said Schedule.
- 4 No person except upon the direction of a police constable in uniform shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 3 to this Notice from making a left turn into the road specified in column 2 of the said Schedule.
- 5 This Order is required to facilitate highway resurfacing works and is necessary for the safety of the workforce whilst carrying out their duties
- 6 This Order shall be cited as Somerset County Council (A38 Shuttern, Upper High Street, Mary Street, Billetfield and Hurdle Way, Taunton) (Temporary Traffic Restrictions) Order 2017.

Temporary Prohibition of Vehicles in an
Eastbound Direction (one way Westbound)

A38 Shuttern, Upper High Street,
Mary Street, Billetfield and Hurdle
Way, Taunton

commencing from a point 50 metres
west of the junction with Burton
Place in an easterly direction for a
distance of 880 metres.

Mount Street, Taunton	From its junction with A38, onto Mary Street (allowing a left turn only onto Upper High Street)
The Mount, Taunton	From its junction with the A38, onto Billetfield (allowing a left turn only onto Mary Street)

Temporary Prohibition of left turn

<u>Column 1</u>	<u>Column 2</u>
Paul Street, Taunton	from its junction with the A38 Mary Street (allowing a right turn only onto Mary Street)
Billet Street, Taunton	from its junction with the A38, onto Hurdle Way (allowing a right turn only onto Billetfield)

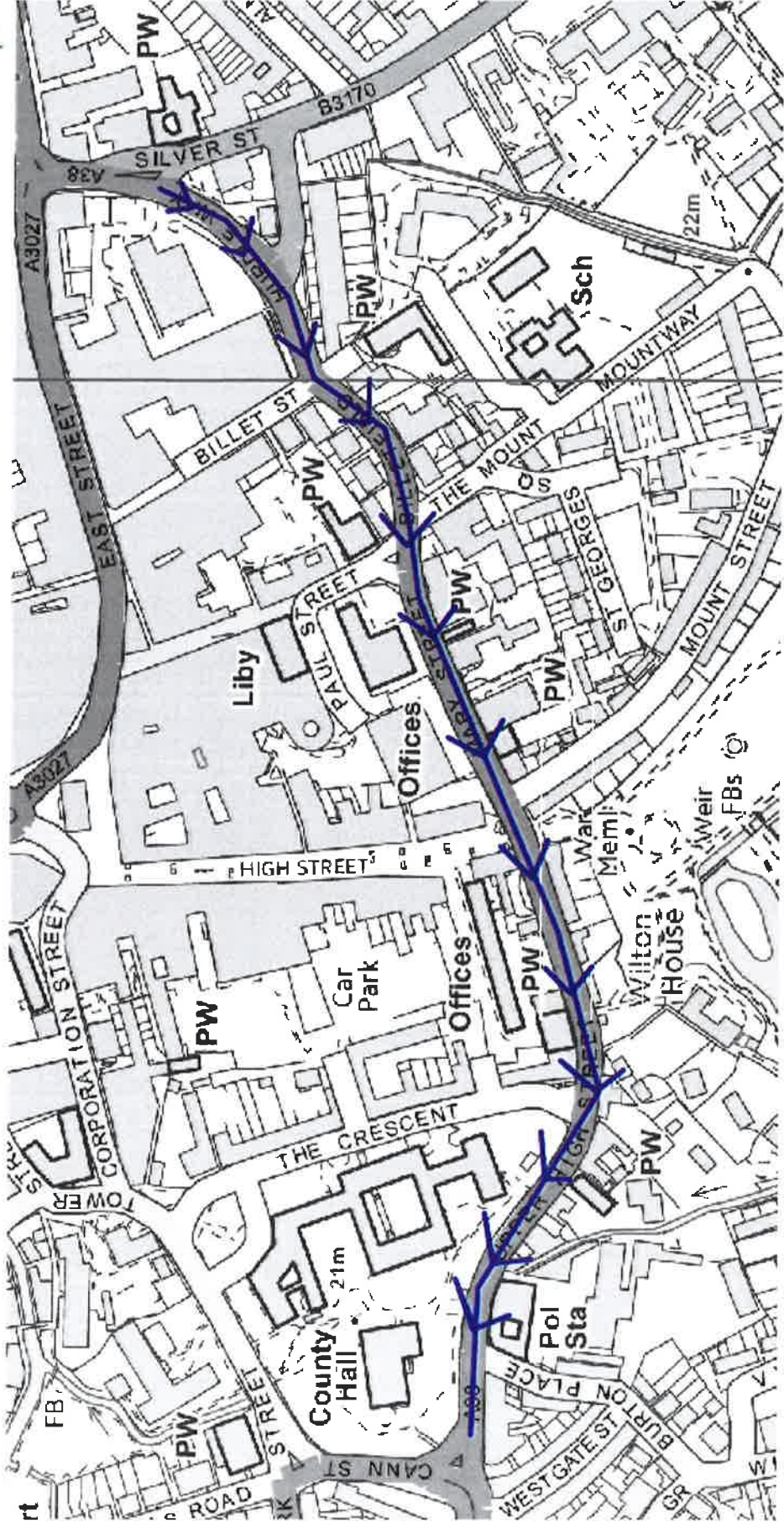
