## SOMERSET COUNTY COUNCIL (WYLDS ROAD, A38 BRISTOL ROAD, AND A39 THE DROVE, BRIDGWATER) (TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2017

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

- 1 This Order shall come into operation on the 23rd day of January 2017 and shall remain in force for eighteen months. The restrictions may not be effected for the whole period but it is anticipated that the roads will be restricted as and when traffic signs are in position and only for so long as is necessary to execute the works.
- 2 No person except upon the direction of a police constable in uniform shall cause or permit any vehicle to proceed in the length of road in Schedule 1 in a Northerly direction.
- 3 No person except upon the direction of a police constable in uniform shall cause or permit any vehicle to proceed in the length of road in Schedule 2 in a Southerly direction.
- 4 No person except upon the direction of a police constable in uniform shall cause or permit any vehicle proceeding in the length of road in column 1 of Schedule 3 to enter the length of road in column 2.
- 5 This Order is required to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties.
- 6 This Order shall be cited as Somerset County Council (Wylds Road, A38 Bristol Road and A39 The Drove, Bridgwater (Temporary Traffic Restrictions) Order 2016.
