

**SOMERSET COUNTY COUNCIL**  
**MARKET PLACE AND TOWNHALL BUILDINGS, WELLS**  
**(TEMPORARY PROHIBITION OF VEHICLES) ORDER 2017**  
**(MAMMOTH SCREEN - FILMING)**

The County of Somerset in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order.

1. This Order shall come into operation on Friday 10<sup>th</sup> February 2017 and will remain in force for a period not exceeding 18 months and may be cited as 'Somerset County Council (Market Place and Townhall Buildings, Wells) (Temporary Prohibition of Vehicles) Order 2017 (Mammoth Screen - Filming).'
  
2. Save as provided in Article 3 of this Order no person shall:
  - (i) cause or permit any vehicle to enter, proceed or wait in the length of road specified in Schedule 1 to this Notice.
  - (ii) except upon the direction or with the permission of a Police Officer in uniform or a Parking Attendant employed by the Local Authority, cause or permit any vehicle to wait on the sides of road or in the lengths of road specified in schedule 1 to this Notice.
  
3. Nothing in Article 2 of this Order shall apply to any vehicle being used for the purpose of maintenance of the road and operations; maintenance of street furniture and infrastructure; supply of gas, water or electricity; agriculture on any land adjacent; the pursuance of statutory powers or duties; vehicles associated with the film production and fire brigade, ambulance or police purposes.

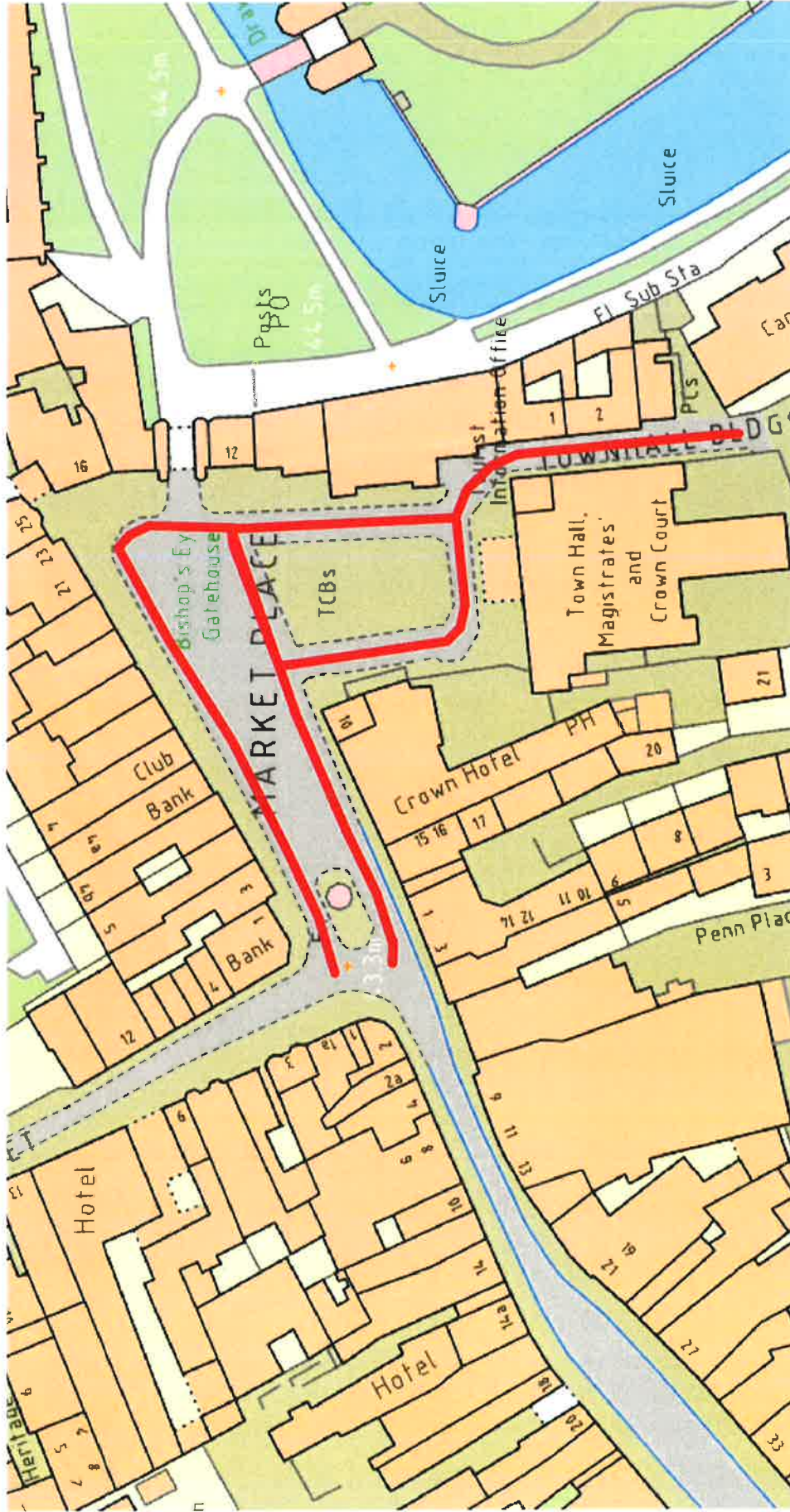
