**ORDER 2016**

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 81 to 84 of the Road Traffic Regulation Act 1984 as amended hereby makes the following Order:

1. This Order shall come into force on the 10th day of February 2017 and may be cited as the "Somerset County Council (A39 Main Road, Putsham Hill, Kilve and Williton to Bridgwater Road, Nether Stowey)(Parishes of Kilve and Holford) (Revocation of 50 mph Speed Limit (East)) (50 mph Speed Limit (East) and Extension of 30 mph Speed Limit) Order 2016".
2. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this order.
3. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in Schedule 1 to this order.
4. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 2 to this order.

**50 mph Speed Limit**

A39 Main Road, Putsham Hill, Kilve, Williton to Bridgwater Road, Nether Stowey	From a point 167 metres east of its junction with Putsham Mead in an easterly direction for a distance of 1760 metres

**Extending existing 30 mph Speed Limit**

A39 Main Road, Kilve, Nether Stowey	From a point 111 metres east of its junction with Putsham Mead in an easterly direction for a distance of 55 metres

**Revocation of 50mph Speed Limit (East)**

A39 Main Road, Kilve, Nether Stowey	Revocation of 50mph Speed Limit (East Only)

# Plan A39 Kilve

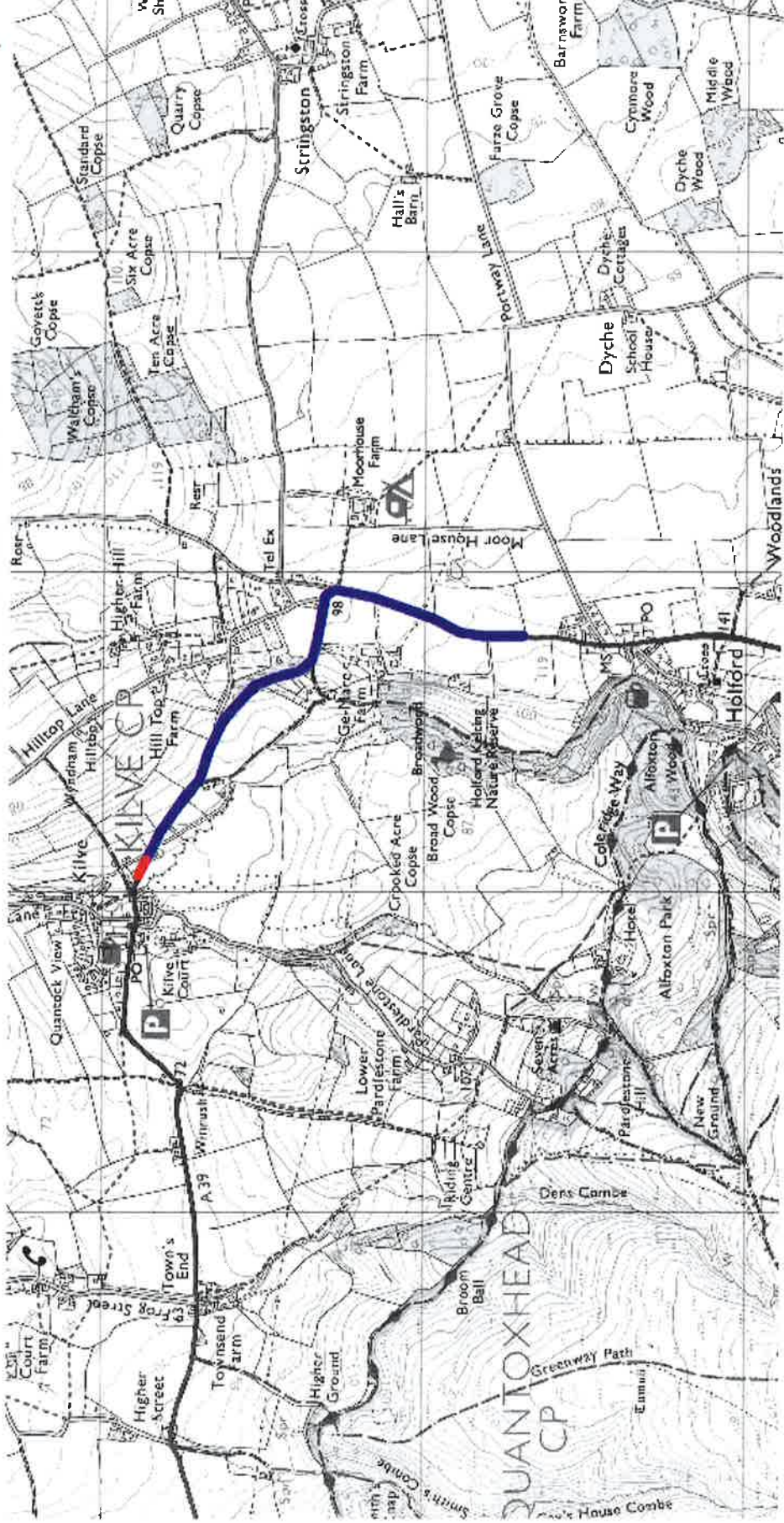
