

SOMERSET COUNTY COUNCIL
(THE COUNTY OF SOMERSET) (ST MICHAELS AVENUE, A30 SHERBORNE ROAD AND LYDE ROAD) (YEOVIL) (PROHIBITION OF RIGHT TURN AND PROHIBITION OF U-TURN) ORDER 2015

THE COUNTY COUNCIL OF SOMERSET in exercise of its powers under Sections 1 (1) and (2) and 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKE THE FOLLOWING ORDER:-

1. This order shall come into operation on the 2nd March 2017 and may be cited as 'The County of Somerset (St Michaels Avenue, A30 Sherborne Road and Lyde Road) (Yeovil) (Prohibition of Right Turn and Prohibition of U-Turn) Order 2015'.
2. Save as provided in Article 3 of this order, no person shall cause or permit;
 - a) any vehicle proceeding in the road specified in column 1 of Schedule 1 to this Notice from making a right turn into the road specified in column 2 of the said Schedule.
 - b) Any vehicle proceeding in the road specified in column 1 of Schedule 2 to this Notice to undertake a U-Turn manoeuvre at any time on the lengths of road as set out in schedule 2 to this order.
3. Nothing in Article 2 of this order shall apply to any vehicle being used for fire brigade, ambulance or police purposes.

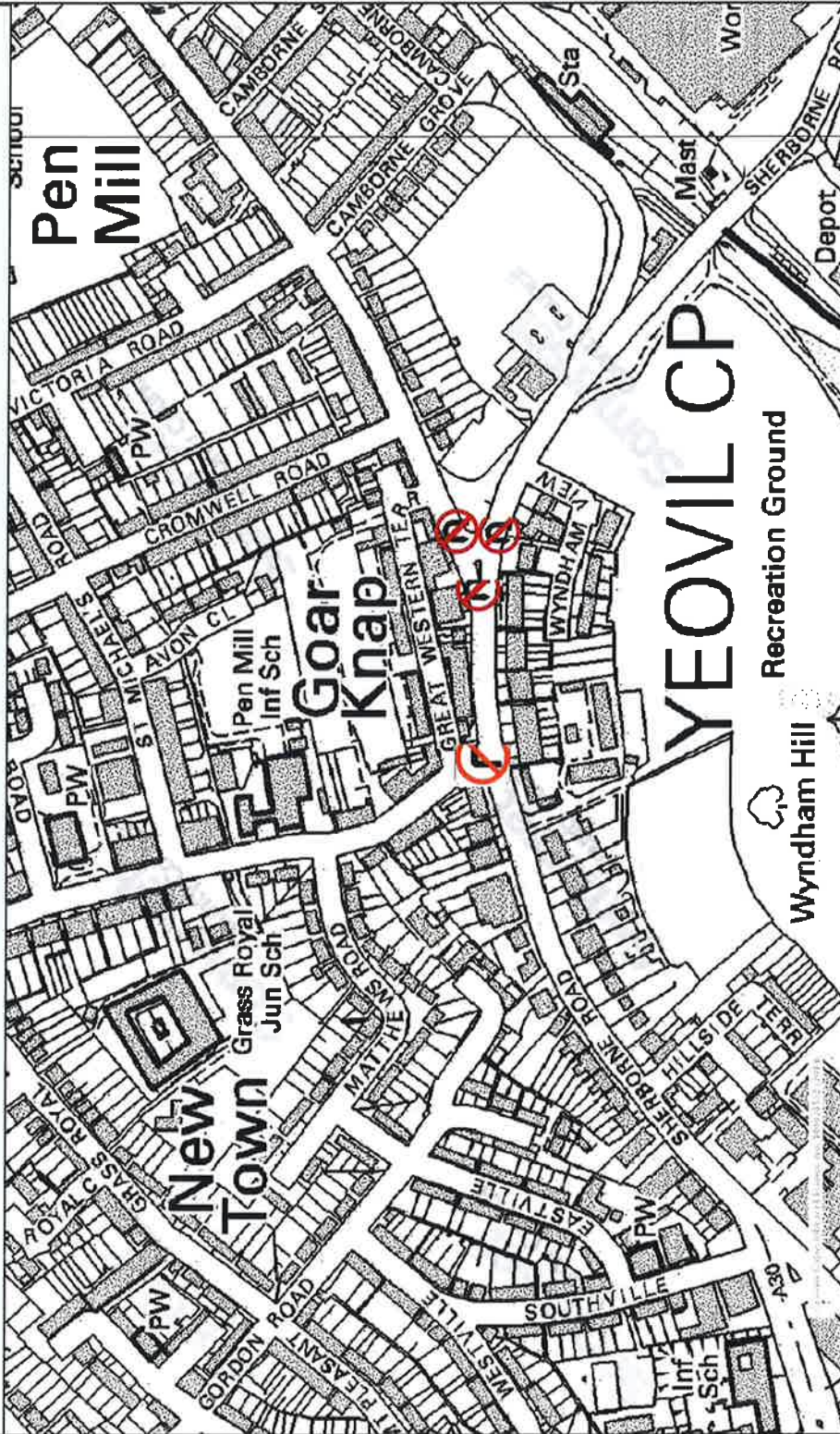
SCHEDULE 2
PROHIBITION OF U-TURN

<u>Column 1</u>	<u>Column 2</u>
A30 Sherborne Road (South East of the junction with Lyde Road), Yeovil	From the westbound to the eastbound side of the carriageway and vice versa (to about turn so as to proceed in the opposite direction)
A30 Sherborne Road (West of the junction with Lyde Road), Yeovil	From the northbound to the southbound side of the carriageway and vice versa (to about turn so as to proceed in the opposite direction)
Lyde road, Yeovil	From the northbound to the southbound side of the carriageway and vice versa (to about turn so as to proceed in the opposite direction)

STATEMENT OF REASONS

The purpose of the order is for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.
