(TEMPORARY PROHIBITION OF MOTOR VEHICLES) ORDER 2017

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Parts III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on 9th March 2017 and may be cited as "Somerset County Council (High Street, Great Ostry, Market Place and Town Street, Shepton Mallet (Temporary Prohibition Of Motor Vehicles) Order 2017".

2. In this Order:

Save as provided in Articles 3 no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Police Community Service Officer (PCSO), cause or permit any motor vehicle to proceed in the section of road specified in the Schedule to this Order.

3. Nothing in Article 2 of this Order shall render it unlawful to cause or permit any motor vehicle to proceed in the length of road referred to in that Article if the vehicle is being used:-

- (a) for the conveyance of goods and merchandise to or from any premises situated on or adjacent to that length of road, provided that any vehicle cannot be used for such purpose before 6 am or after 6 pm on the day the prohibition is in effect;
- (b) to be used in connection with any of the following operations, provided that any vehicle cannot be used for such purpose before 6 am or after 6 pm on the day the prohibition is in effect, namely: -
 - (i) building, industrial or demolition operations in or adjacent to that length of road;
 - (ii) the removal of any obstruction to traffic in that length of road;
 - (iii) the maintenance, improvement or reconstruction of the sides or lengths of that road; or
 - (iv) the laying, erection, alteration or repair in, or on land adjacent to, the sides or lengths of that road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Communications Act 2003;
- (c) in the service of a local authority or a water authority in pursuance of statutory powers or duties;

- (d) in an emergency for Fire Brigade, Ambulance or Police purposes.
- (e) in connection with the setting up and removal of market stalls and scheduled buses.

4. Any existing Traffic Regulation Orders relating to the lengths of roads specified in the Schedule to this Order shall cease to have effect in relation to those lengths of roads on the coming into operation of this Order.

Temporary Prohibition of Motor Vehicles

Shall come into effect between the hours of 0600 hours to 1800 hours on the third Sunday of each month only

Market Place, Shepton Mallet	whole length
Town Street, Shepton Mallet	whole length
High Street, Shepton Mallet	whole length
Great Ostry, Shepton Mallet	from the junction with High Street for a distance of 43 metres in a westerly direction

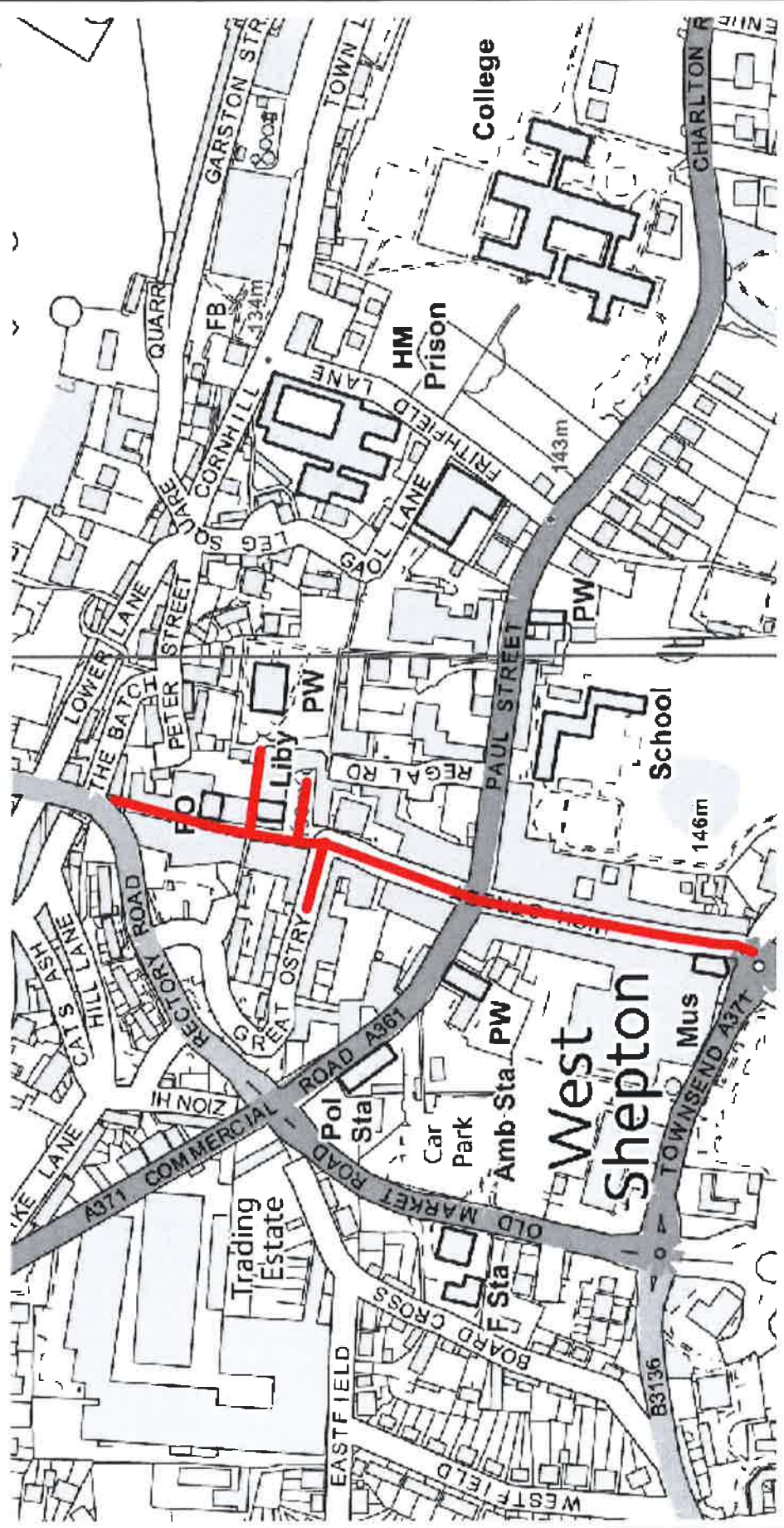
For avoiding danger to persons, or other traffic using the road, or any other road, or for preventing the likelihood of any such danger arising.
