  - (ii) Police, Fire and Ambulance emergency service vehicles.
- 4. This Order may be cited as the Somerset County Council (Various Roads, Burnham on Sea) (Temporary Traffic Restrictions) (Special Events) Order 2017 (Burnham on Sea Triathlon).
