Notice is hereby given that Somerset County Council intends to make an order in pursuance of Section 16 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to introduce the following traffic restrictions, the details of which are described in the schedules to the Order as listed:

- a temporary prohibition of vehicles on Corams Lane, Wellington, (Schedule I)
- a temporary Prohibition of vehicles in a south westerly direction on St Michaels Hill, Milverton (Schedule II, part A)
- a temporary Prohibition of Vehicles in an easterly direction on the B3187, Fore Street, Milverton (Schedule II, part B)
- a temporary Prohibition of Vehicles in a north easterly direction on the B3187, Silver Street, Milverton (Schedule II, part C)
- a temporary Prohibition of Vehicles in a north westerly direction on the B3187, North Street, Milverton (Schedule II, part D)

The Order will be made to facilitate the Taunton Deane Triathlon 2017 and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation at 0830 hours on Sunday the 7th of May 2017 and will remain in force until 1500 hours on Sunday the 7th of May 2017.

Exemptions are provided in the Order for emergency vehicles.

During the operational period of the Order, the 7.5 tonne weight restriction on St Michaels Hill and North Street will be temporarily suspended to allow the one way traffic system in Milverton to be implemented (Schedule III).

- 4. Save as provided in Article 2 of this Order, the 7.5 tonne weight restriction will be temporarily suspended on the lengths of St Michaels Hill and North Street detailed in Schedule III to facilitate the one way traffic system.
- 5. This Order may be cited as Somerset County Council (Various Roads, Wellington and Milverton) (Temporary Traffic Restrictions) (Special Events) Order 2017 (Taunton Deane Triathlon).
