

**SOMERSET COUNTY COUNCIL**

**(TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2017**  
**(GLASTONBURY ROAD RUN)**

Notice is hereby given that Somerset County Council intends to make an order in pursuance of the provisions of Section 16 of the Road Traffic Regulation Act 1984 as amended, the effect of which will be to introduce temporary traffic restrictions as detailed in the schedules below.

The Order will be made to facilitate the Glastonbury Road Run and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation at 0900 hours on Sunday 30<sup>th</sup> April 2017 and will continue in force until 1600 hours on Sunday 30<sup>th</sup> April 2017. Exemptions are provided in the Order for emergency vehicles. The restriction shall apply when indicated by traffic signs.

The County of Somerset in exercise of their powers under Section 16 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order.

1. The Order shall come into operation at 0900 hours on Sunday 30th April 2017 and will continue in force until 1600 hours on Sunday 30<sup>th</sup> April 2017.
2. Save as provided in Article 3 of this Order no person shall cause or permit any vehicle to proceed in the lengths of road specified in the Schedule to this Order between the hours of 0900 and 1600 on Sunday 30th April 2017.
3. Nothing in Article 2 of this Order shall apply:
  - a. to anything done with the permission or at the direction of a police constable in uniform;
  - b. to any vehicle being used for police, fire brigade or ambulance purposes.
4. This Order may be cited as the Somerset County Council (Various Roads, Glastonbury) (Temporary Traffic Restrictions) Order 2017 (Glastonbury Road Run)
