

SOMERSET COUNTY COUNCIL
(A38 BRISTOL ROAD/THE DROVE/UNION STREET)
(PARISH OF BRIDGWATER)
(TEMPORARY PROHIBITION OF MOTOR VEHICLES) ORDER 2017

Notice is hereby given that Somerset County Council intends to make an order in pursuance of the provisions of Section 14 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to introduce a temporary prohibition of motor vehicles as detailed in the schedule below.

The Order will be made to facilitate resurfacing works and is in the interest of public safety.

The Order becomes effective on the 15th May 2017 and will remain in force for eighteen months. The works will commence on the 22nd May 2017 for 8 nights between the hours of 19:00 – 06:00. The restriction will apply when indicated by traffic signs.

Temporary Prohibition of Motor Vehicles

A38 Bristol Road, Bridgwater	From 50 metres south of its junction with Kimberley Terrace in a southerly direction to 50 metres south of its junction with The Drove. A distance of 210 metres.
The Drove, Bridgwater	From its junction with the A38 Bristol Road in a westerly direction for a distance of 80 metres.
Union Street, Bridgwater	From its junction with the A38 Bristol Road in an easterly direction for a distance of 27 metres.
