# SOMERSET COUNTY COUNCIL <br> (VARIOUS ROADS, BROMPTON REGIS) (TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2017 (IRONMAN TRIATHLON EVENT - WIMBLEBALL LAKE) 

Notice is hereby given that Somerset County Council intends to make an order in pursuance of Section 16 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to introduce the following traffic restrictions, the details of which are described in the schedules to the Order as listed:

1. That no person shall cause or permit any vehicle to enter, proceed or wait along those lengths of road specified in Schedule 1 to this Notice.
2. That no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant employed by the Local Authority, cause or permit any vehicle to wait on the sides of road or in the lengths of road specified in Schedule 2 to this Notice.
3. That no person shall drive any vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 3 to this Notice.

The Order will be made to facilitate the 2017 Ironman 70.3 UK Triathlon event and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation at 0600 hours on Friday 23rd June 2017 and will continue in force until 0600 hours on Monday $26^{\text {th }}$ June 2017. The restrictions will apply when indicated by traffic signs.

Exemptions are provided in the Order for emergency vehicles, vehicles or cycles associated with the event, Equestrian vehicles requiring access to the Treborough Hill Horse Trials and for any vehicles being escorted by the Event Traffic Management Officers.

1. This Order shall come into operation at 0600 hours on Friday $23^{\text {rd }}$ June 2017 and will continue in force until 0600 hours on Monday $26^{\text {th }}$ June 2017 and will remain in force for a period not exceeding 18 months and may be cited as "The County of Somerset (Various Roads, Brompton Regis) (Temporary Traffic Restrictions) Order 2017" (Ironman Triathlon Event- Wimbleball Lake). The restrictions will apply when indicated by traffic signs.
2. Save as provided in Article 3 of this Order no person shall;
(i) cause or permit any motor vehicle, horse or any other animal to enter, proceed or wait along those lengths of road specified in Schedule 1 this Notice.
(ii) except upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant employed by the Local Authority, cause or permit any motor vehicle to wait on the sides of road or in the lengths of road specified in Schedule 2 to this Notice.
(iii) drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 3 to this Notice.
3. Nothing in Article 2 of this Order shall apply to:
(i) anything done with the permission or at the direction of a police officer in uniform.
(ii) Police, Fire and Ambulance emergency service vehicles.
(iii) any motor vehicles or cycles associated with the event.
(iv) any Equestrian vehicles requiring access to the Treborough Hill Horse Trials.
