

**SOMERSET COUNTY COUNCIL**

**(TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2017**  
**(ENGLAND V SOUTH AFRICA T20 CRICKET MATCH)**

The County of Somerset in exercise of their powers under Section 16 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order.

1. The Order shall come into operation at 1400 hours on Friday 23<sup>rd</sup> June 2017 and will remain in force until 23:00 hours on Friday 23<sup>rd</sup> June 2017.
2. Save as provided in Article 3 of this Order no person shall cause or permit any motor vehicle to proceed, wait, load or unload along the lengths of road specified in the schedules to this Order.
3. Nothing in Article 2 of this Order shall apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
4. This Order may be cited as "Somerset County Council (Various Roads, District of Taunton Deane) (Temporary Traffic Restrictions) Order 2017 (England V SA T20 Cricket Match)".

St James Street , Taunton	From its junction with North Street to its junction Priory Avenue, a distance of 263 metres
Priory Avenue , Taunton	From its junction with St Augustine Street to its junction with St James Street, a distance of 189 metres
St Augustine Street, Taunton	From its junction with Priory Avenue to its junction Priory Bridge Road, a distance of 306 metres
Canon Street, Taunton	From its junction with Canon Street Car Park to its junction with St James Street and Priory Avenue, a distance of 124 metres
North Street, Taunton	From its junction with Bridge Street to the Burma Memorial, a distance of 511 metres
Priory Bridge Road, Taunton	From its junction with Winchester Street to its junction to Deller's Wharf a distance of 306 metres
Coal Orchard Taunton	From its junction with St James Street for its entire length a distance of 90 metres

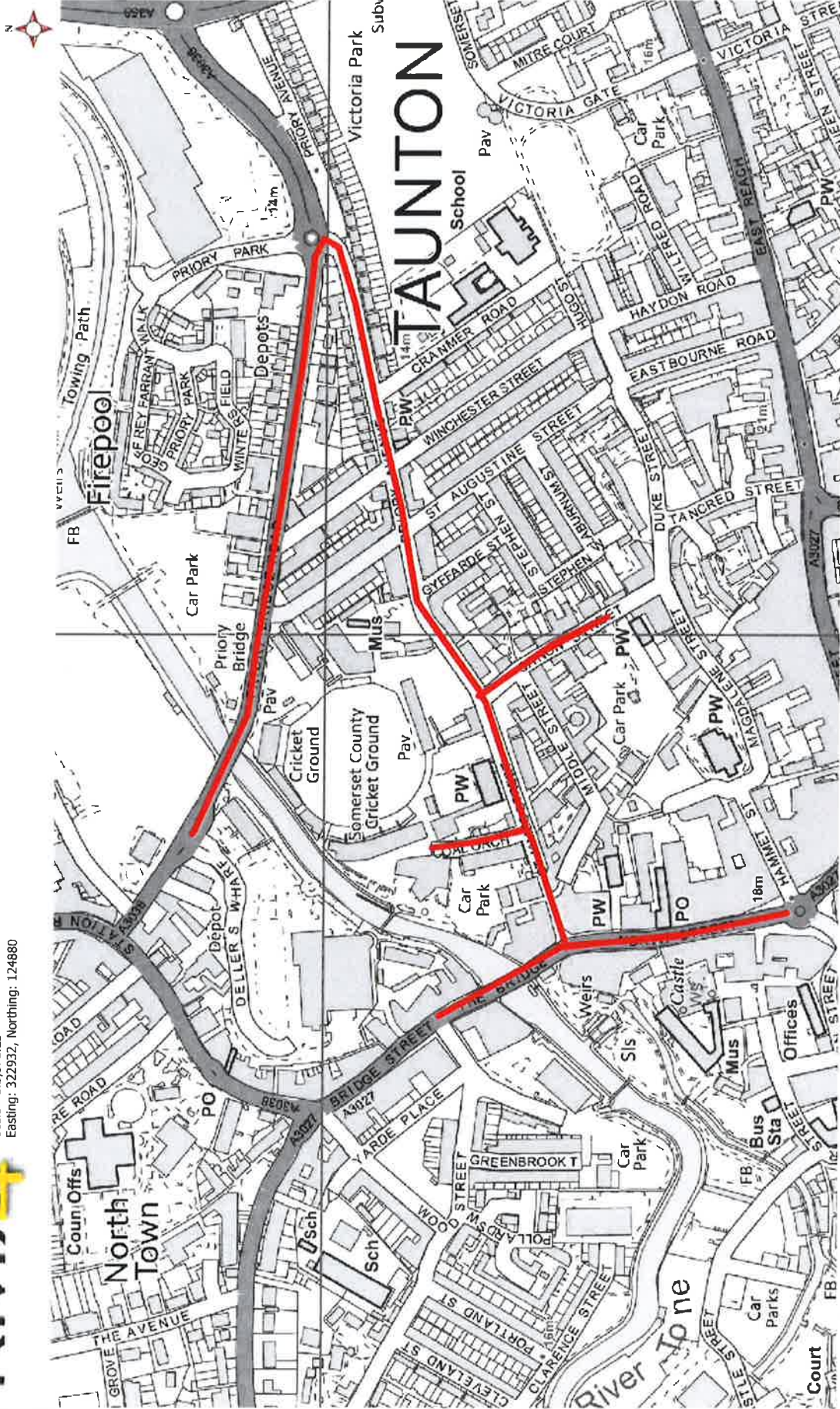
