NOTICE is hereby given that Somerset County Council proposes to make the above Order in pursuance of the provisions of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to introduce a temporary 30 mph Speed Limit and Clearway restriction on the lengths of road specified in the Schedule to this Notice.

The Order will be made to facilitate the Samphire Festival and is in the interest of public safety.

This Order shall come into operation on the 30th day of June 2017 and shall remain in force for eighteen months. The restrictions shall apply when indicated by traffic signs.

The restriction shall come into operation at 0700 hours on the 7<sup>th</sup> July 2017 and will continue in force until 2359 hours on 14<sup>th</sup> July 2017.

- 3 No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule to this order.
- 4 No person shall cause or permit any vehicle to wait, stop or load for any purpose, at any time, on the sides of the road specified in the Schedule to this Order
- 5 This Order shall be cited as the Somerset County Council, A39 Porlock, Temporary 30mph Speed Limit and Clearway Order 2017.
