

**SOMERSET COUNTY COUNCIL**

Notice is hereby given that Somerset County Council intends to make an Order in pursuance of Section 14 of the Road Traffic Regulation Act 1984 as amended, the effect of which will be to introduce the following temporary traffic restrictions in Taunton as detailed in the Schedules to the Order:

The Order will be made to facilitate the Taunton Flower Show 2017 and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation at 0001 hours on Wednesday the 2nd of August 2017 and will continue in force until 2359 hours on Sunday the 6th of August 2017.

**SCHEDULE 1**  
**Temporary prohibition of vehicles**  
**Between the hours of 0800 on Thursday 3<sup>rd</sup> August 2017**  
**and 0700 on Sunday 6<sup>th</sup> August 2017**

Mount Street, Taunton	From its junction with A38 Upper High Street/Mary Street in a south easterly then north easterly direction for its entire length, a distance of 411 metres.
The Mount, Taunton	From Mount Street to its junction with A38, Mary Street/Billetfield, in a north westerly direction for a distance of 266 metres (including a section known locally as Mountway).

**Temporary prohibition of right turn**  
**Between the hours of 0800 on Thursday 3<sup>rd</sup> August 2017**  
**and 0700 on Sunday 6<sup>th</sup> August 2017**

Mount Street, Taunton	From its junction with A38, onto Mary Street (allowing a left turn only onto Upper High Street).

**SCHEDULE 3**  
**Temporary suspension of parking**  
**Between the hours of 0800 on Wednesday 2nd August 2017**  
**and 0700 on Sunday 6<sup>th</sup> August 2017**

The Mount, Taunton	To include the seven parking bays adjacent to Saxum House (Billetfield), a length of highway of 18 metres.
The Mount, Taunton	To include the limited waiting section adjacent to number 6, covering a length of highway of 17 metres.
The Crescent, Taunton	To include the eight parking bays opposite 22 The Crescent, covering a length of highway of 47 metres. This is to provide a temporary Park and Ride Bus Stop.

**SCHEDULE 4**  
**Temporary prohibition of waiting**  
**Between the hours of 0700 on Friday 4th August 2017**  
**and 2200 on Saturday 5<sup>th</sup> August 2017**

Mount Street, Taunton	From the western extent of the boundary of number 4 Mount Terrace to the eastern extent of number 1 Mount Terrace, a length of highway of 50 metres.
Mount Street, Taunton	From the western extent of the boundary of number 17 to number 18a, a length of highway of 36 metres.

Somerset County Council in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order:

The Order shall come into operation at 0001 hours on Wednesday the 2<sup>nd</sup> of August 2017 and will continue in force until 2359 hours on Sunday the 6th of August 2017.

1. Save as provided in Article 2 of this Order, the following temporary traffic restrictions are introduced:
  - i. PROHIBITING ALL VEHICLES from proceeding in a south easterly, then north easterly then north westerly direction along Mount Street then along The Mount (including a section known locally as Mountway) to create a one way traffic system as detailed in Schedule 1 to this Order;
  - ii. PROHIBITING ALL VEHICLES from making a right turn onto Mary Street from Mount Street as detailed in Schedule 2 to this Order;
  - iii. TEMPORARY SUSPENSION OF PARKING on two lengths of The Mount and one length of The Crescent as detailed in Schedule 3 to this Order.
  - iv. TEMPORARY PROHIBITION OF WAITING on two lengths of Mount Street as detailed in Schedule 4 to this Order.
  
2. Nothing in Article 2 of this Order shall apply:
  - i. to anything done with the permission or at the direction of a police officer in uniform;
  - ii. to any vehicle being used for police, fire brigade or ambulance purposes;
  - iii. to event official vehicles leaving the St George School Car Park who may turn right on its exit onto The Mount and proceed in a north westerly direction towards A38, Mary Street/Billetfield.
  
3. This Order may be cited as the Somerset County Council (The Mount, Mount Street and The Crescent, Taunton) (Temporary Traffic Restrictions) Order 2017 (Taunton Flower Show).
