SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

- 1. This Order shall come into operation on the 12th day of October 2017 and shall remain in force for eighteen months. The restrictions shall apply when indicated by traffic signs.
- 2. Save as provided in Article 3 of this Order no person shall cause or permit any motor vehicle to enter, proceed or wait along the lengths of road specified in schedule 1 to this Order
- 3. Nothing in Article 2 of this Order shall apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
- 4. No person shall cause or permit any vehicle to turn right into the Edithmead Leisure Park, as specified column 2 of Schedule 2 to this Order, from A38 Bristol Road, Highbridge, as specified in column 1 of Schedule 2 to this Order.
- 5. The works are expected to start on the 16<sup>th</sup> day of October 2017 and to last for 4 weeks until the 10<sup>th</sup> November 2017.
- 6. This Order may be cited as Somerset County Council A38 Bristol Road Highbridge (Temporary Lane Closure and Temporary No Right Turn) Order 2017
