SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 (1) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- This Order shall come into force on the 13th day of February 2018 and may be cited as the "Somerset County Council, C182 (Rodway, Combwich Road, Withycombe Hill, Road to Hinkley Point, Clayland Corner and Hinkley Point Road) and Brookside Road, Bridgwater (Revocation of Derestricted Speed Limit and Introduction of 50 mph Speed Limit) Order 2018".
- 2. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this order.
- 3. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in Schedule 2 to this order.

SCHEDULE 1 Revocation of derestricted Speed Limit

C182 (Rodway, Combwich Road, Withycombe Hill, Road to Hinkley Point, Clayland Corner and Hinkley Point Road, Bridgwater from a point 153 metres south of the junction with Stradlings Hill in a northerly, westerly and northerly direction for a distance of 5310 metres.

Brookside Road, Combwich, Bridgwater

from the junction with Combwich Road in an easterly direction for a distance of 75 metres.

SCHEDULE 2 50 mph Speed Limit

C182 (Rodway, Combwich Road, Withycombe Hill, Road to Hinkley Point, Clayland Corner and Hinkley Point Road, Bridgwater from a point 153 metres south of the junction with Stradlings Hill in a northerly, westerly and northerly direction for a distance of 5310 metres.

Brookside Road, Combwich, Bridgwater


