

**SOMERSET COUNTY COUNCIL**  
**(VARIOUS ROADS, SOMERTON)**  
**(7.5 TONNE WEIGHT RESTRICTION AND REVOCATION) ORDER**  
**2017(AMENDMENT NO. 1) ORDER 2018**

Somerset County Council in exercise of their powers under Sections 1, 2 and 3(2) of the Road Traffic Regulation Act 1984 as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKE THE FOLLOWING ORDER:-

1. The provisions of the following Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this order.

Somerset County Council (Various Roads, Somerton) (7.5 Tonne Weight Restriction and Revocation) Order 2017

2. Save as provided in Article 3 of this Order, no person shall, other than with the permission of a Police officer in uniform, use, or cause or permit to be used, any heavy commercial goods vehicle in excess of 7.5 tonnes maximum gross weight in such a way that it proceeds along the length of road specified in Schedule 1 to this Order.
3. Nothing in Article 2 of this Order shall make it unlawful for any heavy commercial vehicle in excess of 7.5 tonnes maximum gross weight to proceed along the length of road specified in Schedule 1 to this Order if the vehicle is being used:-
  - (a) for the purpose of loading and unloading to premises situated on or adjacent to the road specified in the Schedule to this Order;
  - (b) in connection with any building operation or demolition in or adjacent to the road, the removal of any obstruction to traffic in the road, the maintenance, improvement, or reconstruction of the road, or the laying, erection, alteration or repair in or adjacent to the road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
  - (c) in the service of a local authority in pursuance of statutory powers or duties;
  - (d) in the service of the Police, Fire or Ambulance services in a case of emergency;
4. This Order shall come into operation on the 6th day of February 2018 and may be cited as the "Somerset County Council (Various Roads, Somerton) (7.5 Tonne Weight Restriction and Revocation)(Amendment No. 1) Order 2018

Badgers Cross Lane	For its entire length
Watts Quarry Lane	From the junction with Langport Road in a northerly direction for a distance of 1636 metres
Polham Lane	From the junction with Sutton Road in an easterly, northerly and then an easterly direction for a distance of 477 metres
Perry Hill Road	For its entire length
Blacks Moor Hill Lane	For its entire length
Great Western Lane	For its entire length

**STATEMENT OF REASONS**

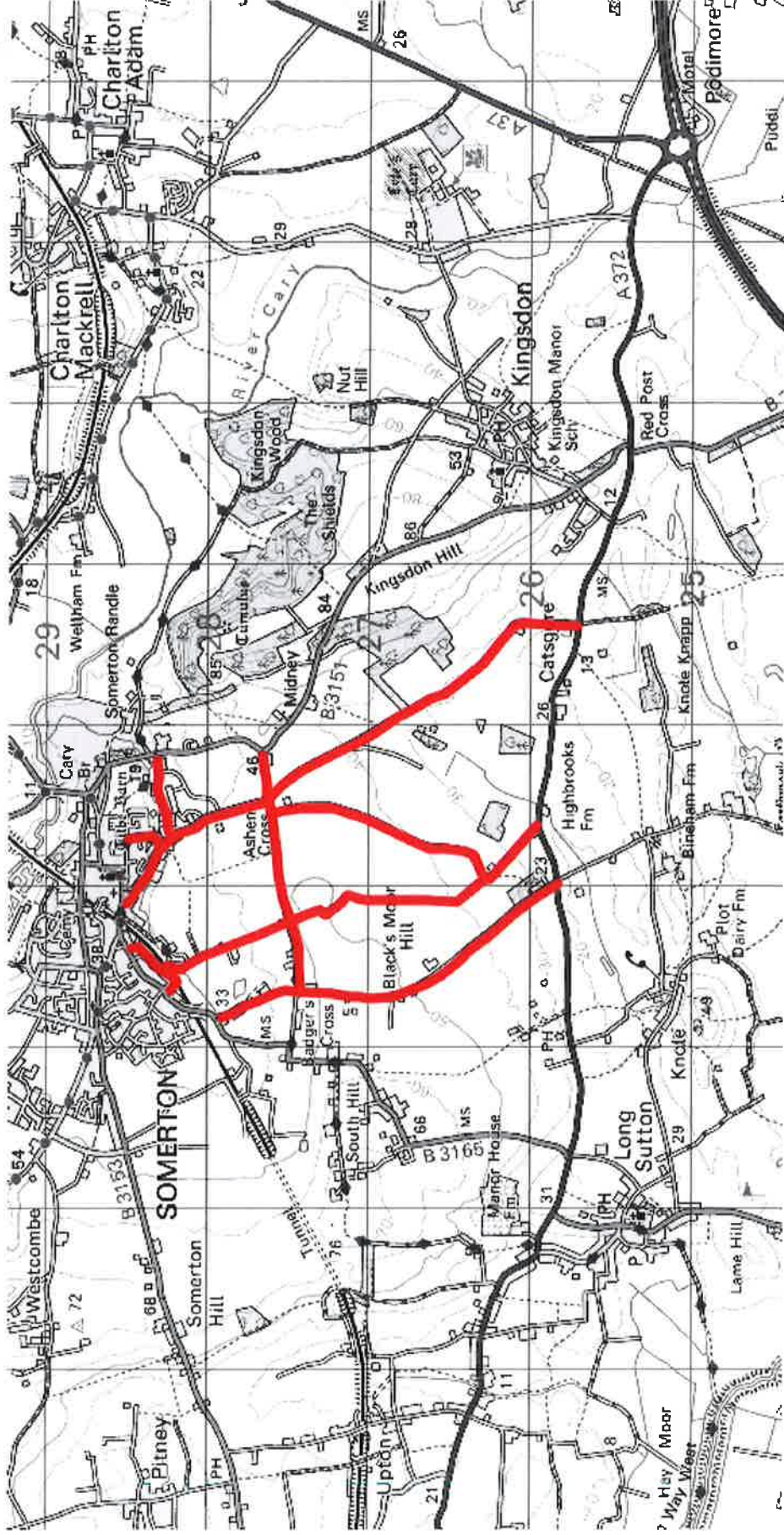
