

**SOMERSET COUNTY COUNCIL**

**AND REVOCATION OF 30MPH SPEED LIMIT)**  
**ORDER 2018**

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 (1) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 21st day of June 2018 and may be cited as the “Somerset County Council (Various Roads, Somerton) (20 mph Speed Limit Zone, 40 mph Speed Limit and Revocation) Order 2018”.
2. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
3. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of road specified in Schedule 1 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in Schedule 2 to this Order

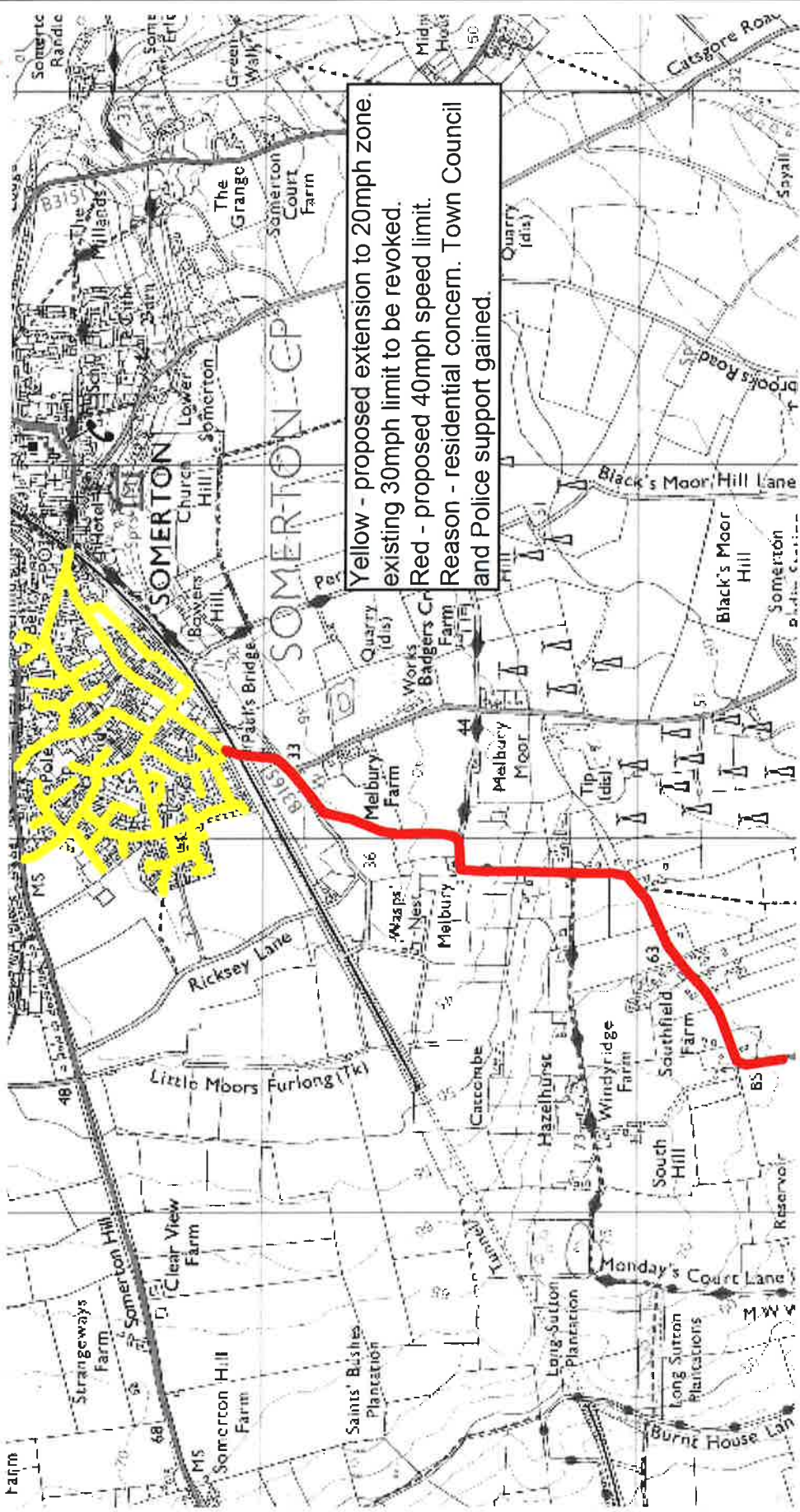
