

**SOMERSET COUNTY COUNCIL**  
**(A378 LANGPORT ROAD AND TOP ROAD) (FIVEHEAD)**  
**(REVOCATION AND 30 MPH SPEED LIMIT)**  
**CORRECTION ORDER 2018**

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 83 and 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 15<sup>th</sup> June 2018 and may be cited as “Somerset County Council (A378 Langport Road and Top Road) (Fivehead) (Revocation and 30 mph Speed Limit) Correction Order 2018”.
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of roads specified in Schedule 1 to this Order.
3. The Order specified in Schedule 2 to this Order is hereby revoked.
4. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

**SCHEDULE 1**  
**30 mph Speed Limit**

A378 – Langport Road Fivehead	From a point 119 metres west of the centre of its junction with Top Road to a point 160 metres east of the centre of its junction with Butchers Hill.
Top Road Fivehead	From the centre of its junction with the A378 Langport Road for a distance of 60 metres in a south westerly direction.

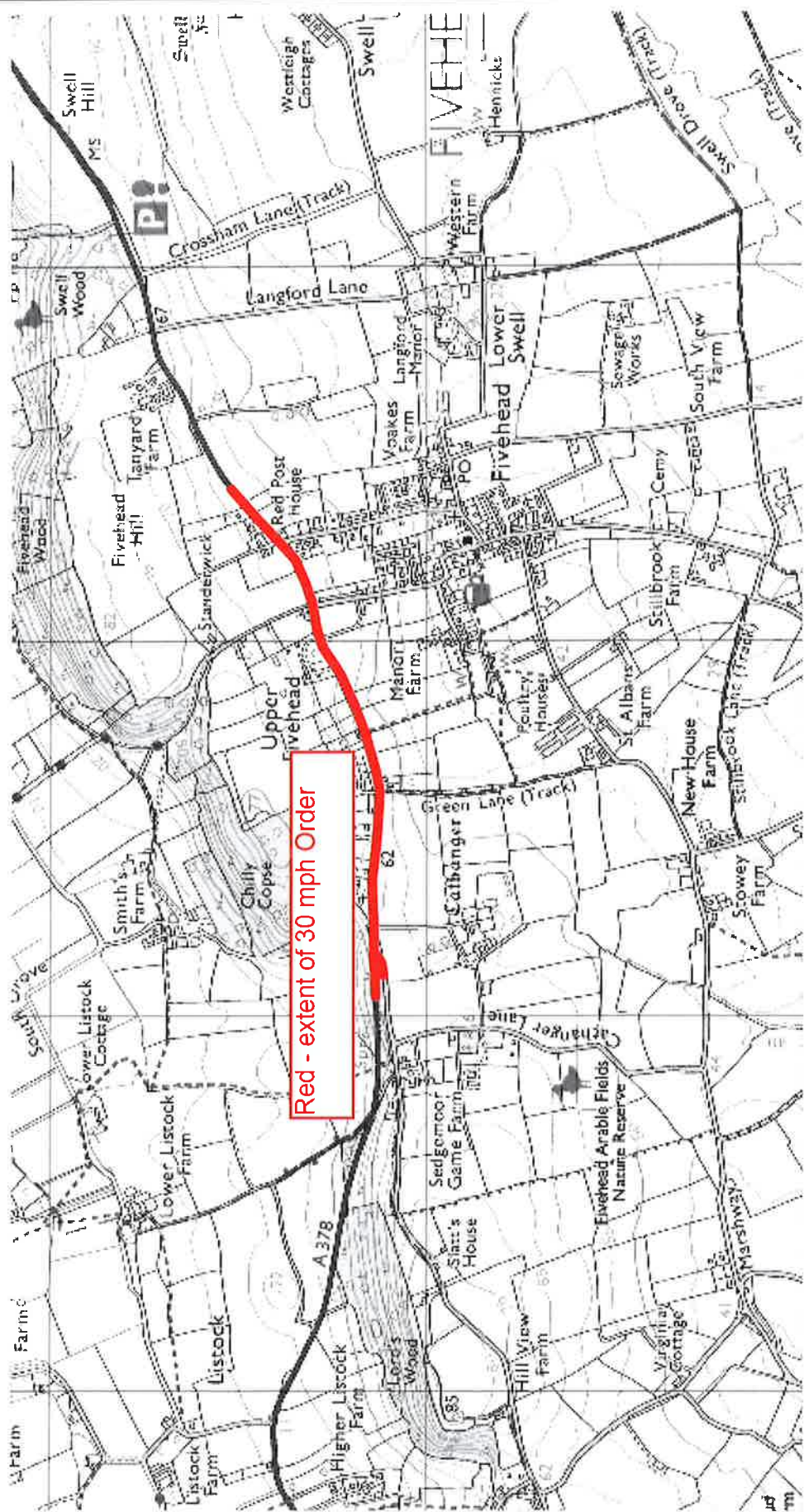
