

**SOMERSET COUNTY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984 as amended**

WHEREAS THE COUNTY COUNCIL OF SOMERSET (hereinafter called "the Council") is the Highway Authority responsible for the maintenance and repair of

Heale Lane, Corfe- from the junction with Orchard Portman Road to Home Meadow Cottage, a distance of 131 metres. Access to be maintained for residents. **The proposed start date is 8th August 2018 for 3 days.**

Church Road, Churchstanton- from the junction with Smeatharpe Road to Church Road Cottages, a distance of 450 metres. **The proposed start date is 10th August 2018 for 5 days.**

Mill Lane, Corfe- from the junction with B3170 Honiton Road for its full extent, a distance of 262 metres. **The proposed date is 21st August 2018 for 8 days**

Newton Lane, Corfe- from the junction with B3170 Honiton Road to the start of Queens Acre Lane, a distance of 64 metres. Access to be maintained for residents. **The proposed start date is 4th September 2018 for 4 days.**

Howstead Road, Otterford- from the junction with Holman Clavel Road to the junction with Honiton Road, a distance of 50 metres. **The proposed date is 4th September 2018 for 3 days.**

Church Road, Pitminster- from the junction with Pitminster Road for its full extent, a distance of 189 metres. Access to be maintained for residents. **The proposed date is 13th October 2018 for 6 days.**

Church Lane, Pitminster- from the junction with Pitminster Road for its full extent, a distance of 69 metres. Access to be maintained for residents. **The proposed date is 23rd October 2018 for 2 days.**

The Green, Pitminster- from the junction with Pitminster Road for its full extent, a distance of 71 metres. Access to be maintained for residents. **The proposed date is 25th October 2018 for 2 days.**

Poundisford Road, Pitminster- From the junction with Pitminster Road to the junction with Newton Lane, a distance of 562 metres. **The proposed date is 27th October 2018 for 10 days.**

Fyfett Lane, Otterford from the junction with B3170 Honiton Road to the property The Old Stable, a distance of 408 metres. **The proposed start date is 10th November 2018 for 6 days.**

in the Parishes of **CORFE, CHURCHSTANTON, OTTERFORD AND PITMINSTER** in the District of **TAUNTON DEANE** in the County of Somerset (hereinafter referred to as "the said road");

AND WHEREAS the Council has given notice in pursuance of Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) of its intentions to make an Order PROHIBITING TEMPORARILY the use of a part of the said road by ALL VEHICULAR TRAFFIC:

NOW THEREFORE the Council in exercise of the powers conferred upon it by virtue of Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) HEREBY MAKES THE FOLLOWING ORDER:-

1. Save as hereinafter mentioned ALL TRAFFIC SHALL BE PROHIBITED from using that part of the said road, for a period not exceeding eighteen months in the first instance until the works being executed or proposed to be executed on or near the said road shall have been completed.
2. This Order is required to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties. The restriction shall apply when indicated by traffic signs.
3. This Order shall come into operation on **2nd August 2018**
4. Nothing in this Order contained shall be deemed to prohibit all traffic from using the above-mentioned length of road EXCEPT THAT PART THEREOF UPON WHICH THE WORKS ARE BEING CARRIED OUT if such use is necessary
 - (i) for the conveyance of persons, goods or merchandise to or from any lands or premises situate on or adjacent to the length of road hereinbefore described; or
 - (ii) for the purpose of agriculture in connection with land adjoining or lying near to the length of the said road or for the conveyance or haulage of timber felled upon such land.

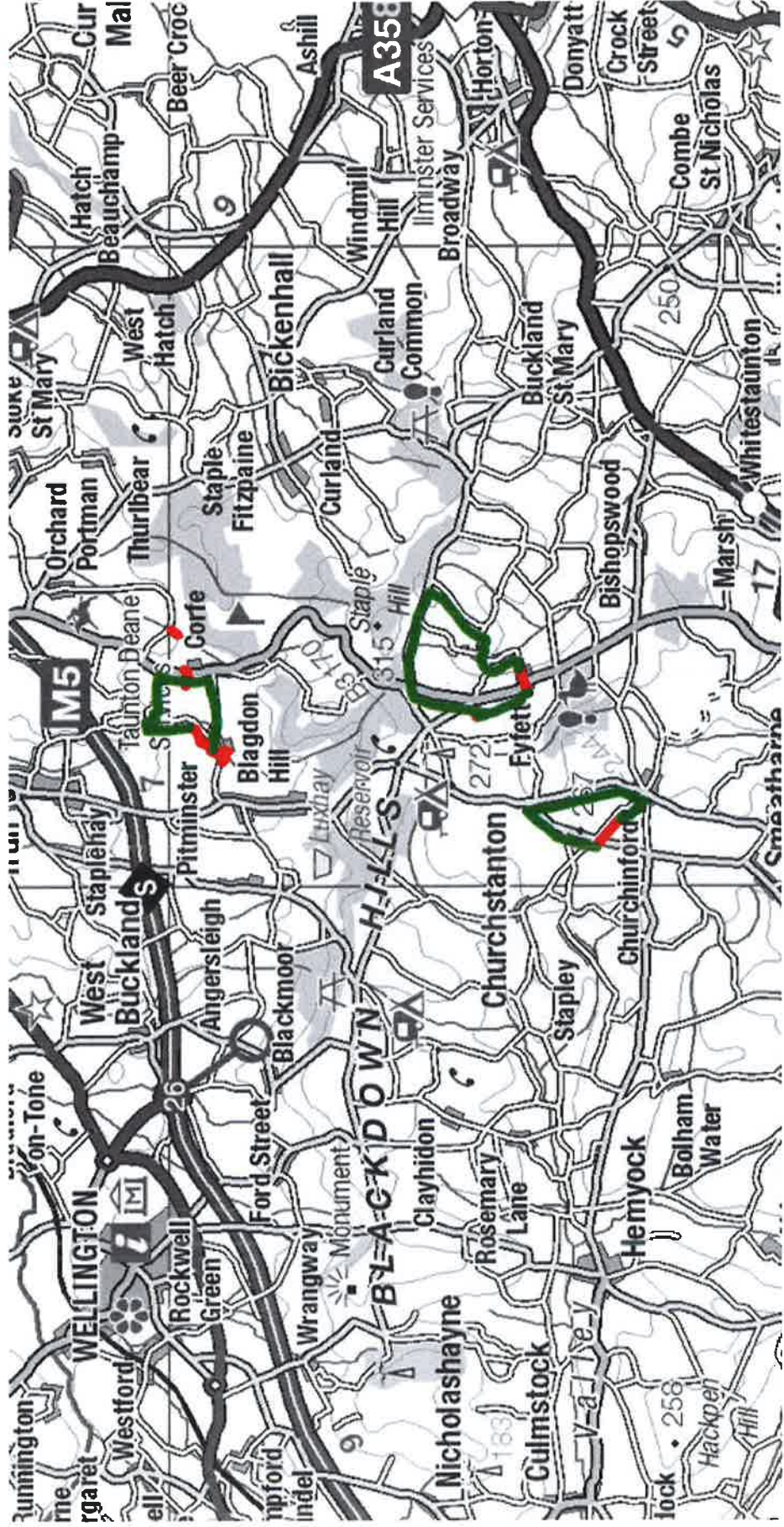
