Notice is hereby given that Somerset County Council intends to make an Order in pursuance of Section 14 of the Road Traffic Regulation Act 1984 as amended, the effect of which will be to introduce the following temporary traffic restrictions in Crewkerne as detailed in the Schedules to the Order:

The Order will be made to facilitate St. Bartholomew's Fair (Crewkerne Fair) 2018 and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation at 1700 hours on Thursday the 6th of September 2018 and will continue in force until 2330 hours on Saturday the 8th of September 2018.

Somerset County Council in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order:

The Order shall come into operation at 1730 hours on Thursday the 6th September 2018 and will continue in force until 2330 hours on Saturday the 8th of September 2018.

1. Save as provided in Article 2 of this Order, the following temporary traffic restrictions are introduced:
 - i. PROHIBITING ALL VEHICLES from A356 North Street, A30 Church Street (Westbound Carriageway), Market Street (Northbound Carriageway) and A356 Market Square to East Side of Town Hall as detailed in Schedule 1 to this Order;
 - ii. PROHIBITING ALL VEHICLES from making a right turn on A30 East Street, Abbey Street, A356 South Street, A30 Church Street and A30 East Street as detailed in Schedule 2 to this Order;
 - iii. PROHIBITING ALL VEHICLES from proceeding in a northwards direction from its junction with the A30 Market Square and from its junction with A356 Market Square (East Side of Town Hall) in a generally southerly direction to create a one way traffic system as detailed in Schedule 3 to this Order;
2. Nothing in Article 2 of this Order shall apply:
 - i. to anything done with the permission or at the direction of a police officer in uniform;
 - ii. to any vehicle being used for police, fire brigade or ambulance purposes:
3. This Order may be cited as the Somerset County Council (A356 Market Square, A30 Market Square, A30 Market Street, Church Street, Crewkerne) (Temporary Traffic Restrictions) Order 2018 (St. Bartholomew's Fair (Crewkerne Fair)).
