(30MPH SPEED LIMIT) ORDER 2018

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 1st day of November 2018 and may be cited as the "Somerset County Council (Various Roads, Wells) (30 mph Speed Limit) Order 2018".
2. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule to this Order.

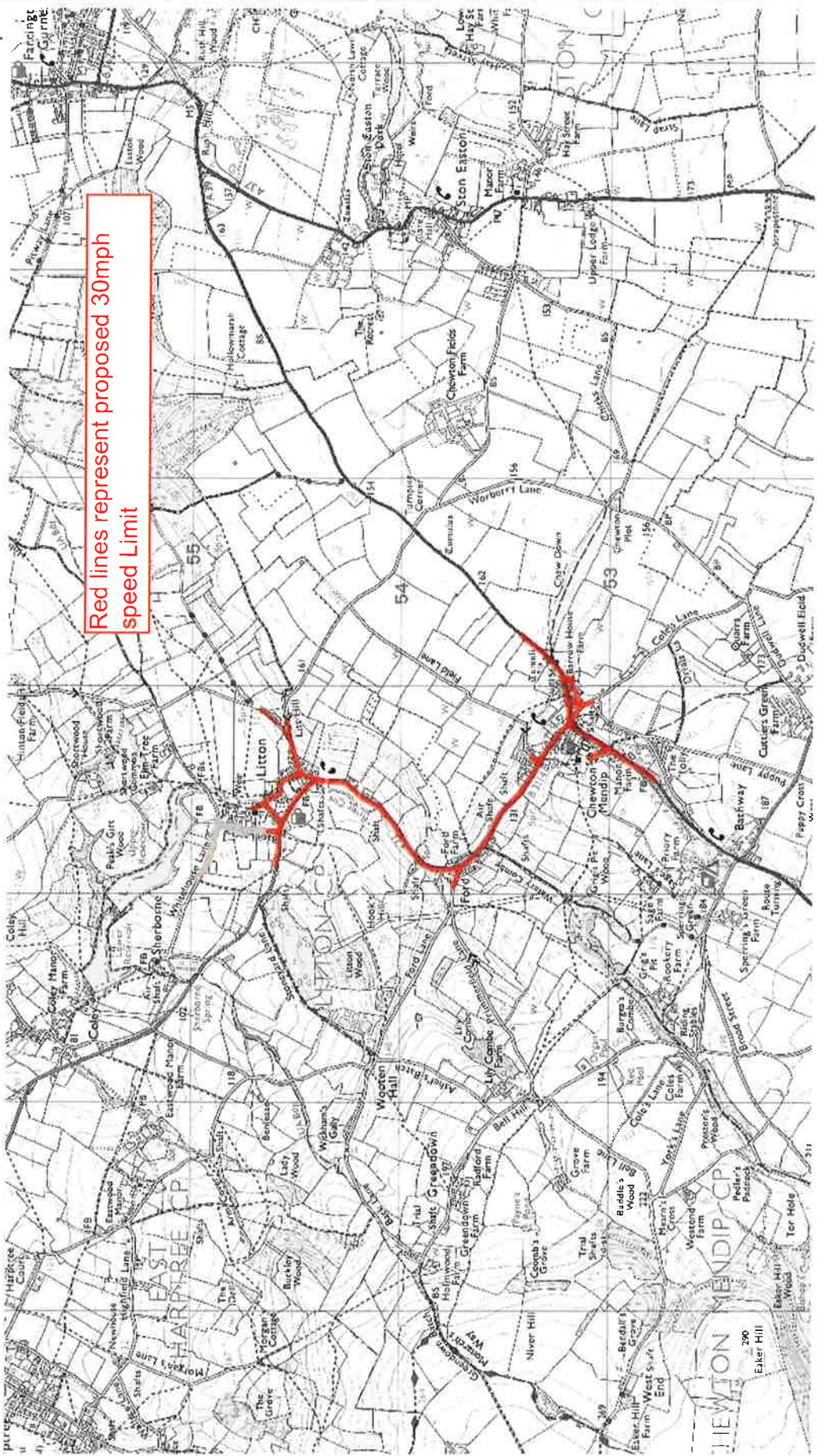
