SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

This Order shall come into operation on the 10th January 2019 and shall remain in force for eighteen months. The effect of which will be to introduce a temporary prohibition of a left turn into the road specified in the Schedule to this Order.

This Order is required to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties. The restriction shall apply when indicated by traffic signs.

The works are expected to start on Monday 14th January 2019 and last for 12 days between the hours of 0800 to 1700.

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

1. This Order shall come into operation on the 10th day of January 2019 and shall remain in force for eighteen months. The restrictions shall apply when indicated by traffic signs.
2. Save as provided in Article 3 of this Order No person shall cause or permit any vehicle to turn left onto Welshmill Road, as specified in the Schedule to this Order, from Bridge Street
3. Nothing in Article 2 of this Order shall apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform;
 - (ii) Police, Fire and Ambulance emergency service vehicles.
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
4. The works are expected to start on the 14th January 2018 at 0800 and last until the 25th January 2019 at 1700.
5. This Order may be cited as Somerset County Council Bridge Street, Frome Temporary Prohibition of Left Turn onto Welshmill Road – Order 2018
