This Order shall come into operation on the 10<sup>th</sup> January 2019 and shall remain in force for eighteen months. The effect of which will be to introduce a temporary prohibition of a left turn into the road specified in the Schedule to this Order.

This Order is required to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties. The restriction shall apply when indicated by traffic signs.

The works are expected to start on Monday 14<sup>th</sup> January 2019 and last for 12 days between the hours of 0800 to 1700.
