

SOMERSET COUNTY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984 as amended

WHEREAS THE COUNTY COUNCIL OF SOMERSET (hereinafter called "the Council") is the Highway Authority responsible for the maintenance and repair of

Western Lane, Priddy – Junction with West Harptree Road to Junction with Smitham's Hill, a distance of 1896 metres. The proposed date of the closure is **14th January 2019 for 4 days**.

Latches Lane, Cheddar– Junction with Nyland Farm approach to Junction of Court Farm Approach, a distance of 125 metres. The proposed date of the closure is **1st February 2019 for 6 days**.

Lane between Middle Stoughton and Stoughton Cross, Wedmore – Intersection with Lane Between West Stoughton and Middle Stoughton to Junction of Lascot Hill, a distance of 400 metres. The proposed date of the closure is **1st February 2019 for 10 days**.

Notting Hill Way, Chapel Allerton– Junction with Quab Lane to Junction with Rawlings Lane, a distance of 995 metres. The proposed date of the closure is **1st May 2019 for 7 days**.

Millway Road, Rodney Stoke– Junction of Wells Road and Millway to Junction of Stoke Street and Millway, a distance of 500 metres. The proposed date of the closure is **2nd May 2019 for 5 days**.

in the Parishes of **CHAPEL ALLERTON, CHEDDAR, PRIDDY, RODNEY STOKE, WEARE AND WEDMORE** in the Districts of **MENDIP & SEDGEMOOR** in the County of Somerset (hereinafter referred to as "the said road");

AND WHEREAS the Council has given notice in pursuance of Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) of its intentions to make an Order PROHIBITING TEMPORARILY the use of a part of the said road by ALL VEHICULAR TRAFFIC:

NOW THEREFORE the Council in exercise of the powers conferred upon it by virtue of Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) HEREBY MAKES THE FOLLOWING ORDER:-

1. Save as hereinafter mentioned ALL TRAFFIC SHALL BE PROHIBITED from using that part of the said road, for a period not exceeding eighteen months in the first instance until the works being executed or proposed to be executed on or near the said road shall have been completed.
2. This Order is required to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties. The restriction shall apply when indicated by traffic signs.
3. This Order shall come into operation on **10th January 2019**
4. Nothing in this Order contained shall be deemed to prohibit all traffic from using the above-mentioned length of road EXCEPT THAT PART

THEREOF UPON WHICH THE WORKS ARE BEING CARRIED OUT
if such use is necessary

- (i) for the conveyance of persons, goods or merchandise to or from any lands or premises situate on or adjacent to the length of road hereinbefore described; or
- (ii) for the purpose of agriculture in connection with land adjoining or lying near to the length of the said road or for the conveyance or haulage of timber felled upon such land.
