TAKE NOTICE that in pursuance of Section 14 of the Road Traffic Regulations Act 1984, as amended, Somerset County Council propose to make an Order to introduce a temporary 20 mph speed limit along the on the lengths of road specified in the Schedule to this order.

This Order shall come into operation on 22nd January 2019 and will remain in force for eighteen months.

This Order is required to facilitate highway works and is necessary for the safety of the workforce whilst carrying out their duties. The restriction shall apply when indicated by traffic signs.

Somerset County Council in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended and of all other enabling, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on 22nd January 2019 and will remain in force for a period not exceeding 18 months and may be cited as Somerset County Council (Various Locations, Bridgwater West) (Temporary 20 mph Speed Limit) Order 2019
2. No person shall drive any vehicle at a speed exceeding 20 mph on the lengths of roads specified in the Schedule to this Order. The restriction shall apply when indicated by traffic signs.
3. Nothing in Article 2 of this Order shall apply to:
 - a. Anything done with the permission or at the direction of a police officer in uniform:
 - b. Police, Fire and Ambulance emergency service vehicles.
 - c. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
4. The provisions of any other Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
