

**SOMERSET COUNTY COUNCIL**  
**(VARIOUS ROADS, DONYATT)**  
**(REVOCATION, 30MPH SPEED LIMIT AND 40MPH SPEED LIMIT) ORDER 2018**

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order shall come into force on the 3<sup>rd</sup> day of January 2019 and may be cited as "Somerset County Council (Various Roads, Donyatt) (Revocation, 30 mph Speed Limit and 40mph Speed Limit) Order 2018".
2. The provisions of any other Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule 1 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule 2 to this Order.
5. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
