

**Somerset County Council
District of South Somerset
Parishes of West & Middle Chinnock, West Crewkerne,
Merriott, Lopen and Cudworth
Temporary Prohibition of Vehicles**

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after communicating with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following order:

1. This Order will come into operation on the 21st day of February 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in schedules to this Order
3. Nothing in Article 2 of this Order will apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform;
 - (ii) Police, Fire and Ambulance emergency service vehicles.
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

This Order may be cited as Somerset County Council, District of South Somerset in the Parishes of West & Middle Chinnock, West Crewkerne, Merriott, Lopen and Cudworth Temporary Prohibition of Vehicles

Temporary Prohibition of Vehicles**

| Sakers Cross Lane, West Crewkerne | From its junction with Chard Lane to its junction with Woolminstone Road, a distance of 1115 metres. The proposed date of the closure is 25th February 2019 for 3 days. |
| Snails Hill/ Duckpool Lane West Chinnock | From its junction with Scotts Way to its junction with Highfield, a distance of 260 metres. The proposed date of the closure is 26th February 2019 for 4 days. |
| Scotts Way, West Chinnock | From its junction with the A356 Furringdons Cross, a distance of 420 metres. The proposed date of the closure is 2nd March 2019 for 4 days. |
| Cudworth Street, Cudworth | From its junction with Dowlish Lane to the junction with Cudworth Road, a distance of 1200 metres. The proposed date of the closure is 4th March 2019 for 11 days. |
| School Lane, Lopen | For its entire length. The proposed date of the closure is 4th March 2019 for 2 days. |

Statement of reasons for making the Order

- a) Because works are being or are proposed to be executed on or near the road;
or
- b) because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to such works.
