This Order will come into operation on the 21<sup>st</sup> day of February 2019 and will remain in force for twenty-four months. The effect of which will be to introduce a Temporary 30mph Speed Limit on the road specified in the schedule to this Order.

The works are expected to start on the 4<sup>th</sup> day of March 2019 for a period of twenty-four months. The restrictions will only apply when indicated by traffic signs.

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in the Schedule to this Order.

- 3. Nothing in Article 2 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
- 4. This Order may be cited as Somerset County Council (District of Taunton Deane) (Parish of West Monkton) (Temporary 30mph Speed Limit) Order 2019.
