Order 2019

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 81 to 84 of the Road Traffic Regulation Act 1984 as amended hereby makes the following Order:

1. This Order shall come into force on the 21st Day of February 2019 and may be cited as the "Somerset County Council (Somerset County Council A30 West Coker Road, Camp Road and Culvers Grave Road, Coker Parish of East Coker (Revocation Of 40mph Speed Limit and 30 Mph Speed Limit) Order 2019
2. The provisions of any other Order are hereby revoked but only in so far as they are affected on the length of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule 2 to this Order.

Nothing in Article 3 of this Order shall apply to

4. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

Revocation of 40 mph Speed Limit**

A30, West Coker Road, Coker	From a point 20 metres east of the junction with Nash Lane for a distance of 365 metres.
Camp Road, Coker	From its junction with the A30 West Coker Road for a distance of 70 metres
Culvers Grave Road Coker	From its junction with A30 West Coker Road for a distance of 35 metres

**Schedule 2
30 mph Speed Limit**

A30, West Coker Road, Coker	From a point 20 metres east of the junction with Nash Lane for a distance of 365 metres.
Camp Road, Coker	From its junction with the A30 West Coker Road for a distance of 70 metres
Culvers Grave Road Coker	From its junction with A30 West Coker Road for a distance of 35 metres
