

**Somerset County Council**

**(Temporary Prohibition of Vehicles,**  
**30mph Speed Restriction and 10mph Convoy Working) Order 2019**

Somerset County Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be to introduce a temporary, Prohibition of Vehicles on the lengths of road as detailed in the Schedule 1 of this Order. To introduce a temporary 30mph Speed Restriction, on the lengths of road detailed in Schedule 2 of this Order. To introduce a 10mph Convoy Working Restriction on the length of footway detailed in Schedule 3 of this Order

The Order will come into operation on the 28<sup>th</sup> May 2019 and will remain in force for eighteen months. The works will commence on the 10<sup>th</sup> June for sixteen weeks. The restriction will apply when indicated by traffic signs.

The Order will be made to facilitate construction works and is in the interest of public safety.

Somerset County Council in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order.

The Order will come into operation on the 28<sup>th</sup> May 2019 and will remain in force for eighteen months. The works will commence on the 10<sup>th</sup> June 2019 for sixteen weeks. The restriction will apply when indicated by traffic signs.

1. Except as provided in Article 3 of this Order no person shall cause or permit any motor vehicle to enter, proceed or wait along the lengths of road specified in the Schedule 1 to this Order.
2. Except as provided in Article 3 of this Order no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in the Schedule 2 to this Order.
3. Except as provided in Article 3 of this Order no person shall drive any motor vehicle at a speed exceeding 10 miles per hour on the length of road specified in the Schedule 3 to this Order.
4. Nothing in Articles 1, 2 and 3 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform:
  - (ii) Police, Fire and Ambulance emergency service vehicles.
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
5. This Order may be cited as the Somerset County Council (A39 Quantock Road and Skimmerton Lane) (Parish of Wembdon) Sedgemoor (Temporary Prohibition of Vehicles, 30mph Speed Restriction and 10mph Convoy Working) Order 2019

### **Statement of reasons for making the Order**

- a) Because works are being or are proposed to be executed on or near the road;  
or
- b) because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to such works.
