

**Somerset County Council

(Temporary 40mph Speed Limit)  
Order 2019**

Somerset County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into operation on the 16th day of May 2019 and will remain in force for eighteen months. The restrictions will only apply when indicated by traffic signs.
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule to this Order.
3. Nothing in Article 2 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
4. This Order may be cited as Somerset County Council (District of Taunton Deane) (Parish of Bishops Lydeard) (Temporary 40mph Speed Limit) Order 2019.

Temporary 40mph Speed Limit**

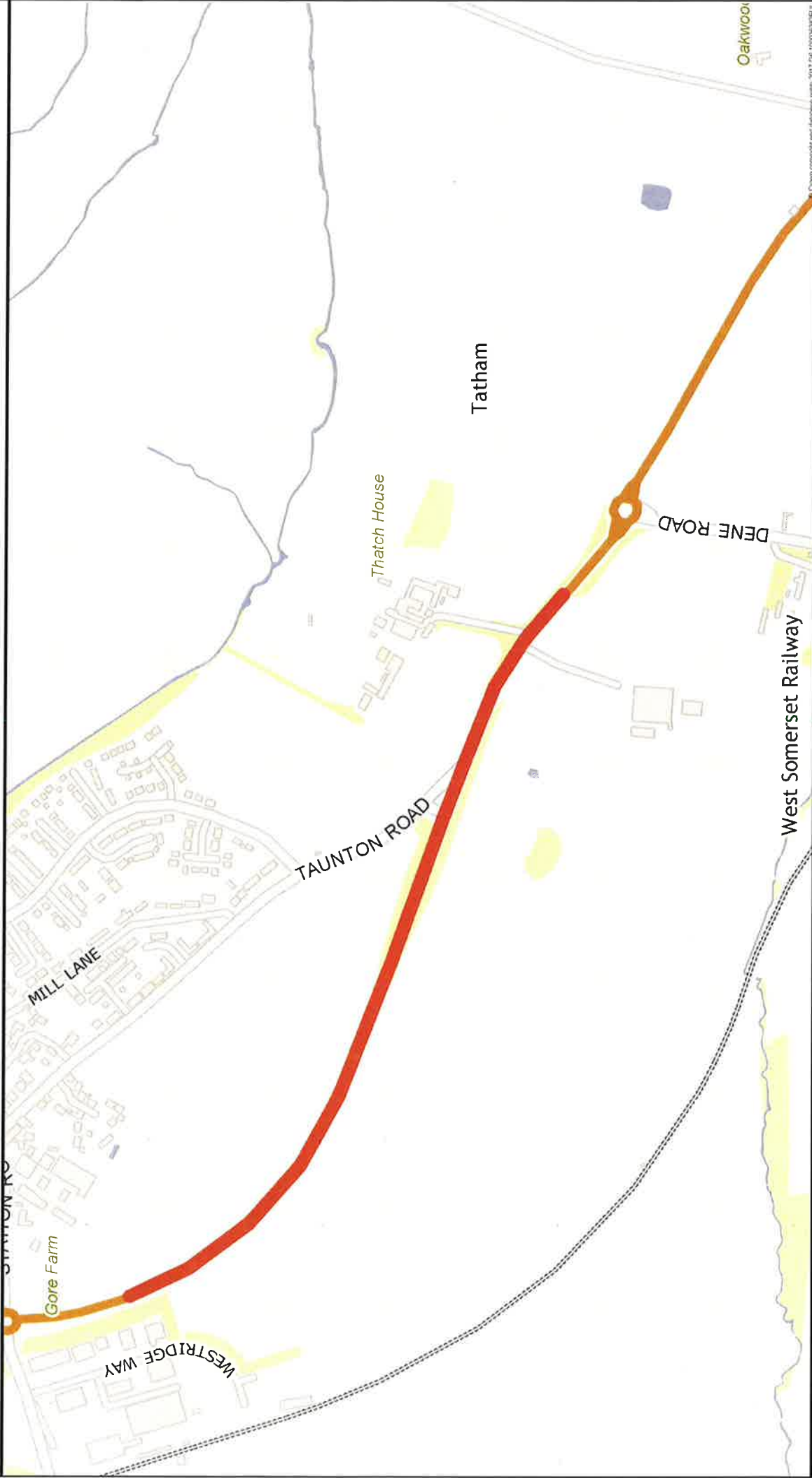
A358 Minehead Road
