The Council of the County of Somerset in exercise of its powers under Sections 1 , 2, 4, 32, 35, 45, 46, 49, 53, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), as amended; and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004"), as amended, and all other enabling powers; and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby **proposes to** make the following Order:-

SCHEDULE 1

SCALE OF CHARGES FOR ADDITIONAL PERMIT TYPES

The following scale of charges for various parking permits in Somerset are in accordance with the provisions of The Act of 1984.

Permit Type	Permit Zone	Annual Charge
Non-resident Landlord permits	All resident parking areas in Somerset	One zone (per District) - £150 per year Three zones (per District) - £300 per year All zones (per District) - £600 per year
Carer Permit	All resident parking areas in Somerset	£10 – max 2 hour stay
Loading Permit	All areas where on- street parking controls exist in Somerset	£100 per year – 20 minutes at a time
Waivers (Suspensions and dispensations)	All areas where on- street parking controls exist in Somerset	Daily - £10 per bay (or equivalent) Weekly - £30 per bay (or equivalent) Monthly - £100 per bay (or equivalent) Admin Fee - £10
Business Permits	All areas where on- street parking controls exist in Somerset	£150 per year
